

Senate May 9 -2

"At its meeting on May 3, the faculty of the College of Arts and Sciences voted to recommend to the Senate the following changes in numbers. This was recommended by the Extension Committee:

English 119 a and b	Changed to	114 a and b
English 120 a and b	" "	110 a and b

Hygiene to be given No. 5 "

The following recommendation from the College of Arts and Sciences was presented:

"At its meeting May 3, the Faculty of the College of Arts and Sciences voted to recommend to the Senate that the name of Miss Bernice Young be included among this year's graduates and that her diploma be sent to her parents."

It was voted to request the Registrar to include Miss Young's name in the list of candidates for degrees.

The Chairman of the Graduate School Committee recommended that the Hon. Edwin P. Morrow be granted the degree of Doctor of Laws. The Chairman of the Committee was asked to notify him that unless he be present, the degree would not be granted.

Miss Simrall presented a recommendation from the Social Committee that the Senate approve the establishing of an honorary Home Economics organization with the object of obtaining a charter from Phi Upsilon Omicron, National Honorary fraternity. The Senate approved the organization."

MINUTES OF THE SENATE SATURDAY JUNE 11, 1921

The Senate met Saturday, June 11, Doctor Boyd presiding.

The following recommendations from the Rules Committee were approved:

1. Concerning the Dropping of Students on Probation

"At the end of his semester of probation the student will be dropped unless he has made a standing of .7 on his entire semester's schedule, or grades of A, B and C in 12 credit hours of work."

2. Commencement Honors

a. Students are graduated "With High Distinction" who attain a standing of 2.6 or higher.

b. Students are graduated "With Distinction" who attain a standing of 2.4 or higher, up to 2.6.

c. Students may receive "Honorable Mention" who attain a standing of 2.2 or higher, up to 2.4.

d. Students may be given commencement honors who qualify under our present rule when applied to the full four years.

The following recommendations of the Committee on Student Social Affairs was read and referred to the committee for further consideration:

Concerning Departmental Clubs

Meeting: All meetings of departmental clubs which include any social features must be held in the afternoon between 3:30-6:00 p.m., except on Saturday, when they may be held in the evening.

Membership: Membership in departmental clubs shall be open only to those doing major or minor work in the given department.

Concerning Locality Clubs

Locality Clubs may meet only in the afternoons between 3:30-6:00 p.m., except on Saturday, when they may hold evening meetings.

Concerning General Social Functions

All social entertainments with the exception of

1. The Senior Ball
2. The Junior Prom.
3. The Military Ball
4. The Pan-Hellenic

must be scheduled for Saturday evenings. ✓

Upon recommendation of the Arts and Sciences faculty, the Senate adopted a motion disapproving of special holidays or celebrations by any one college of the University.

The following recommendation from the Law faculty was read and the first and second paragraphs approved. The third paragraph was referred to Dean Lafferty, Doctor Terrell and President McVey for recommendations:

"The faculty of the College of Law requests permission: ✓

1. To give the final examinations to all seniors.
2. To give a general examination at the end of the senior year, to cover all courses offered in the College of Law.
3. To confer the degree of J.D. (Jurum Doctor) upon students who complete the law course and who have previously received a college

degree. The present rule places seniors who have done college work on equal footing with other students who have only completed one year of college work in the conferring of degrees. The proposition is to make a distinctive class of those who have a college degree. Practically all of the law schools are doing this now for the purpose of encouraging students to take a full college course in addition to the law."

The following recommendation from the Graduate School Committee was approved:

"As Chairman of the Graduate School Committee I present to the Senate the name of John J. Tigert to be recommended by the Board of Trustees for the degree of Doctor of Laws to be conferred at our next commencement, June 15."
