In connection with the consideration of the calendar the question arose as to whether the University should continue to have a summer commencement convocation. A special committee, composed of Thomas P. Cooper, P. P. Boyd, and W. S. Taylor, was appointed to consider this matter and report back to the Faculty.

The following general policies respecting the change of the University from the semester to the quarter system, were submitted by Dean Hill for the consideration of the Faculty:

1. That the second semester of 1941-42 be shortened one week by eliminating Thursday, April 9, and Monday, April 13, from the previously scheduled Easter holidays and by advancing the second semester examinations and commencement exercises. Under this program second semester examinations will begin on May 21 and end on May 28. Baccalaureate

services will be held on Thursday, May 28, and commencement exercises on Friday, May 29.

2. That Junior Club Week be held the week of June 1.

3. That the normal maximum load for a student in the summer quarter be eighteen quarter hours, except as otherwise approved by the dean of the student's college.

4. That in general the summer quarter of 1942 will have to operate on a period of seventy-five minutes in order to provide for the completion of four and five quarter hour courses within the period of approximately five and one-half weeks. For example, in the fall, winter, and spring quarters, a former three semester hour course in English may very readily be converted into a four or five quarter hour course in English, but in the summer quarter work must be completed in the middle of the quarter so that students attending for only one term of the summer quarter will receive credit.

5. That care be taken by the colleges and heads of departments to balance approximately slight increases in total amount of time consumed by courses under the quarter system with slight decreases. For example, if all three semester hour courses are converted into four quarter hour courses the total amount of class time is decreased. If all three semester hour courses are converted into courses of five quarter hours then the total class time is increased. Approximately half of the three hour courses should be converted into four quarter hour courses and half into five quarter hour courses for the specific purpose of balancing the load so that little extra staff time is required for the quarter system.

6. That under the quarter system no fractional credits of any kind shall be permitted.

7. That schedules of classes be made out for three quarters at one time.

8. That deans and heads of departments utilize the change to the quarter system as an opportunity to evaluate the entire program of offerings.

The only specific action taken on these policies was to approve the operation of a seventy-five minute period during the coming summer session. While the other policies were not formally approved, the consensus seemed to be that they might be used for the guidance of the administration and faculty in making the change attending the shift to the quarter system.

The Faculty approved the following course proposed by the College of Engineering:

Metallurgy 141. Alloy Steels. (2) I or II

The thermal behavior of low and high alloy steels is discussed on the basis of each particular phase diagram. The sub-critical transformation of austenite in alloy steels and the physical properties of the products of this type of decomposition of austenite are reviewed.

Martensite and intermediate transformations are treated. The heat treatment of complex alloy steels such as the high speed and high alloy die steels receives particular emphasis. Lectures and recitations, 2 hours a week. Prerequisites: Met. 140 or Met. 36.

This course is to be offered during the second semester of the current school year.

February 5, 1942

The following resolution from the Student Government Association was read to the Faculty:

RESOLUTION OF THE STUDENT GOVERNMENT ASSOCIATION
OF THE UNIVERSITY OF KENTUCKY
passed January 15, 1942

"Whereas, there is an understandable tendency on the part of many University of Kentucky students to leave school because they fear they may be drafted before the twelfth week of the semester, and

Whereas, during the last war students who registered in good faith were granted credits if they left school at any time during the semester to serve in the armed forces, and

Whereas, it is felt that the functions of the University may be seriously impaired if there is a drastic drop in its student enrollment, and

Whereas, it is felt equally that students should be encouraged to continue in school for as long as possible,

Therefore, the Student Government wishes most respectfully to request that the recent recommendations of the University Faculty upon this point be modified as follows:

I. That any student who receives notice of induction into the armed forces in accordance with the Selective Service Act after he has
