The University Faculty approved Dean Stahr's motion that these recommendations be adopted.

Dean Spivey presented recommendations of the Graduate Council that certain courses approved for undergraduate credit be allowed graduate credit and recommending approval of new strictly graduate courses. These recommendations were approved.

II. The Graduate Council recommends approval of the following strictly graduate courses:

Agricultural Extension 202a-d. (3 each) Nesius, Summers

Special Problems in Agriculture or Home Economics Ext.

Directed independent study of research relative to a particular problem in Extension and the study of a selected problem.

Agricultural Extension 500-1,2,3 (0) Thesis.

Commerce 238. Production Management. (3) Haynes
A study of the administration and control of manufacturing activities. Emphasis on decision making and formulation of policy with respect to production.
Analysis of cases. Visits to industrial plants.

Dean Spivey also presented a recommendation from the Graduate Faculty that the rule concerning residence for the doctor's degree be revised.

The Graduate Faculty recommends the following revision of our rule concerning residence for the doctor's degree; the revision is in the nature of amplification and clarification.

The rule now reads as follows: "A minimum of three collegiate years of resident graduate work, of which at least the last year in residence must be spent at the University of Kentucky, is required for the doctorate."

The revision recommended is as follows: "A minimum of three collegiate years of graduate work above the bachelor's degree (two above the master's, or its residence equivalent) is required for the doctorate. At least two semesters, exclusive of summer sessions, of the required residence above the master's (or its residence equivalent) must be earned at the University of Kentucky in full-time devotion to graduate study, or to a combination of graduate study, research, and part-time teaching at the University. 'Residence equivalent' to the master's degree is interpreted as thirty-six weeks of official residence."

This recommendation was also approved by the University Faculty.

President Donovan introduced Coach Blanton Collier who spoke to the Faculty on the academic phases of the football program. This discussion had been requested

by the Committee on Planning and Policy. Coach Collier presented an outline of his aims for the football teams and quoted some figures to show that the trend was toward better scholastic records by team members.

The Faculty adjourned.
