EXPLANATION OF THE MAP AREAS

PREFACE

Notes: Areas A, B, C, and I are assumed to have been under the jurisdiction of Austin from March 18, 1834 to the earliest date mentioned in each case. Prior to 1834, the jurisdiction of Austin was limited to the area now comprising Hays County.

The publication herewith presented, an index to the probate cases filed in Hays County, Texas, is No. 105 of the Texas series of counties. The publication is intended to meet the requirements of day-to-day usage by the officials of the county, attorneys, businessmen, and other citizens who have occasion to consult probate case records for the proper conduct of their affairs. The publication may be used by historians and genealogists to obtain references to unpublished source material.

The names of the deceased persons, minors, and other principals are arranged alphabetically, with reference to the filing date of the case and the case number. The following numbers in series 1-1777 were not used as case numbers: 130, 288, 290, 295-302, 310, 312, 322, 340, 348, 349, 351, 369, 374, 392, 399, 405, 408, 410, 435, 442, 452, 460, 467, 476, 481, 482, 558, 578, 636, 637, 703-707, 709, 710, 797, 868, 875, 949, 1031, 1058, 1122, 1153, 1183, 1251, 1311, 1447, 1496, 1510, 1554, 1569, 1593, 1655, 1706, 1761.

In Hays County all probate records are in the custody of the county clerk. Probate case papers are kept in file boxes in the clerk's vault. The cases are arranged numerically by case number.

Since the transfer of territory from one county to another has affected probate jurisdiction and has determined the county in which the probate case should have been filed, a map and table of territorial changes are included herein. Notations concerning present location and availability of records pertinent to Hays County follow:

- Bastrop County, Bastrop, all records extant.
- Bexar County, San Antonio, all records extant.
- Gonzales County, Gonzales, all records extant.
- Guadalupe County, Seguin, all records extant.
- Travis County, Austin, all records extant.

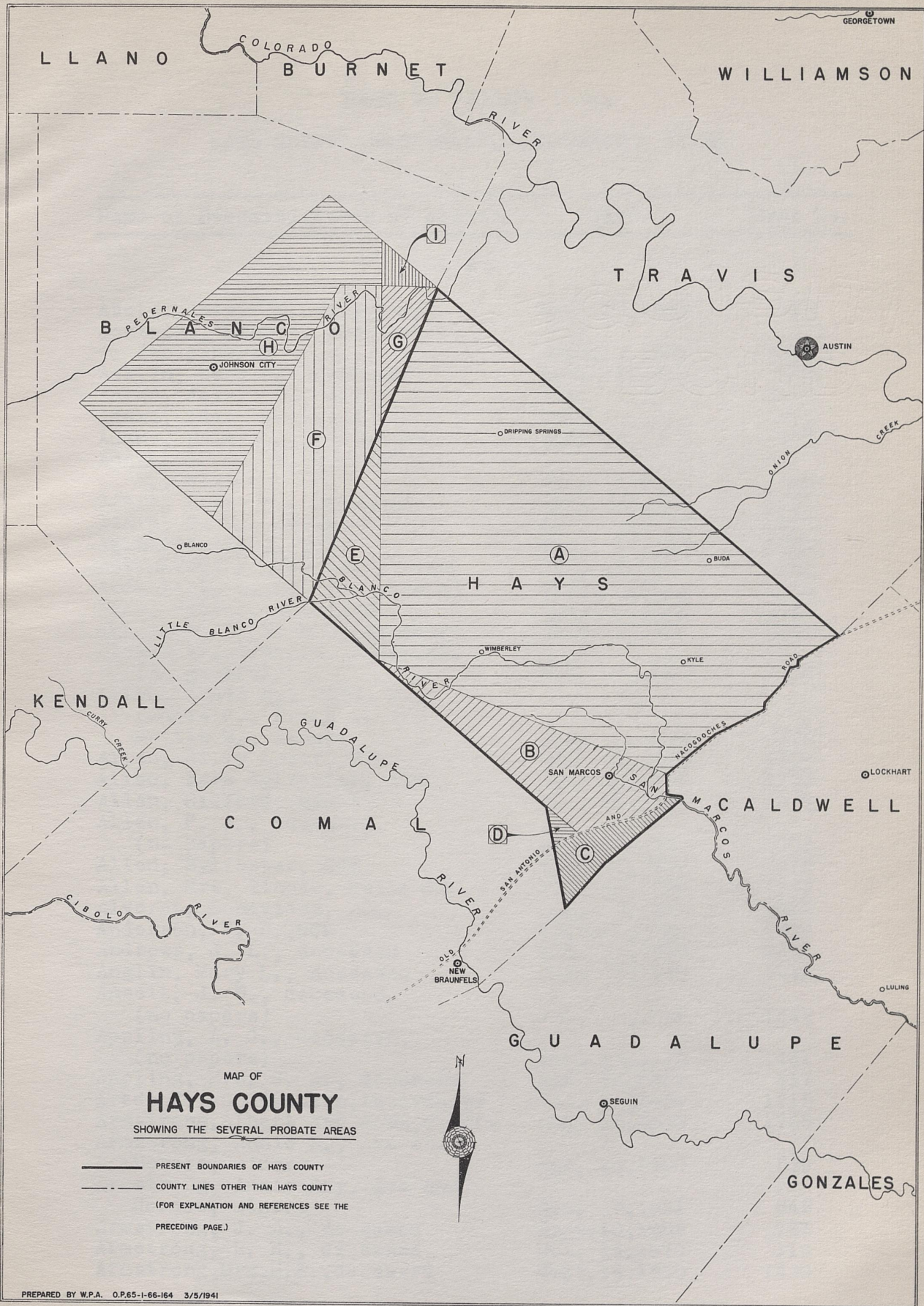
EXPLANATION OF THE MAP AREAS

Note: Areas A, B, D, G, and I are assumed to have been under the jurisdiction of the municipality of Austin from March 18, 1834 (1) to the earliest date mentioned in each case. Prior to 1834 all the areas except C were in the Department of Bexar and presumably came under the jurisdiction of the municipality of Bexar. Area C was in Bexar until November 12, 1832 (6).
