## MINUTES OF THE SENATE MARCH 10, 1924

The University Senate met in the Little Theatre Monday, March 10, President MoVey presiding.

The minutes of February 11 were read and approved.

The Senate approved the request of the Women's Administration Council to be allowed representation on the University Senate and the Women's Discipline Committee. This request had been referred to the Senate from the Council.

Permission was granted the class in Public Speaking to Organize a University Oratorical Glub.

The report of the Women's Discipline Committee on the rule governing cheating was referred to the Rules Committee.

President MoVey read a card of appreciation from Mrs. P. K. Holmes, to the Faculty for their expressions of sympathy in her recent bereavement.

The following recommendation of the College of Arts and Sciences was approved:

## Change in Group Requirement

- 1. That mathematics be dropped from the group of physical sciences and substituted for Education in the group with philosophy and psychology. This new arrangement is to apply to new students entering the college in September 1924, or later; and in other cases where no hardship will be worked.
- 2. That for new students entering the college in September or later, who take the combined Arts-Education course, substituting 20 credits of Education for the major, 20 credits must be gained in one minor, rather than 10 in each of two."

The following recommendations from the Law faculty were approved:

1. That the following titles be dropped from the schedule of courses offered by the College of Law:

Introductory Law Common Law Pleading Code Pleading Court Practice Office Practice

2. That the following courses be added to the schedule of courses for which credit will be given in the regular session of the College of Law.

## MINUTES OF THE SENATE MAY 12, 1924

The University Senate met in the Little Theatre Monday, May 12, Mr. Boyd presiding.

The minutes of March 10 were read and approved.

The Senate voted that candidates to receive their degrees in absentia must have the approval of the Deam of the College.

Senate approved the Registrar's request that in evaluating the standing of candidates for degrees, their extension and correspondence work be included.

Senate failed to approve the recommendation of the Rules Committee that all cases of cheating in University work be referred to the Students Council.

The following recommendations of the College of Arts and Sciences were approved:

## Combination Courses in Law and Medicine

"A student may combine his courses in Arts and Sciences and Law or Medicine under the following conditions:

- 1. He must gain at least 97 credits in Arts and Sciences subjects with a standing of 1 or more.
- 2. He must have met the specified requirements of the College of Arts and Sciences excepting the 20 credits in the major subjects.
- 3. He must have been registered in the College of Arts and Sciences for at least one full year immediately preceding the completion of his Arts and Sciences requirements, and must have gained at least 30 credits in Arts and Sciences subjects in this college.
- 4. The fourth year, the year of professional work, must be dome in the College of Law of the University of Kentucky, this subject to the approval of the Arts and Sciences faculty, or in a "class A" medical school.
- 5. He must in his law or medicine work secure sufficient semester credits to bring his total in the Arts and the professional work up  $^{\rm to}$
