## INTRODUCTION

The year, 1976, marked the 70th anniversary of the enactment of the first Kentucky Commercial Feed Law. The law's initial objective of assuring that feeds are truthfully labeled to advise the feed purchaser of its composition and safe usage has remained unchanged. The scientific and technological advancements in ration formulation and feed manufacturing has produced constant change in trying to meet this objective. The early regulatory efforts centered on analyzing grain by-products and simple rations of mixed grains for protein content and verifying the ingredient listing. During the period of 1913-42 feeds were additionally checked for fat and fiber content. By 1950 feeds were being analyzed for calcium, phosphorus, salt, urea, fluorine and manganese content. The first drug analysis was made for sulfaquinoxaline in 1951. Current activities denote even more remarkable changes during the last 25 years. During 1976 tests were conducted for 37 different feed nutrients and components including routine proximate analysis, urea, macro and trace minerals, invert sugar, vitamin A, drugs and antibiotics. A monitoring of feeds for pesticide residue and aflatoxin was initiated.

Commercial feed as defined includes all materials which are offered for sale as feed or for mixing in feed, except unprocessed and unmixed seed and other exempt commodities, such as; raw meat, hay, straw, stover, silage, cobs, husks and hulls when unground and not mixed. The requirement for registration of commercial feeds, other than custom mixes, with the Division of Regulatory Services prior to distribution within the State provides an initial opportunity to review product labeling. The labeling of approximately 2,500 commercial feeds is reviewed annually for compliance with labeling requirements. Approximately 6,000 different commercial feeds are registered for distribution by 500 feed companies. These feeds range in diversity from specialty pet foods to livestock feeds and ingredients.

Regulatory Inspectors made 3,662 inspectional calls on feed manufacturers and retailers of bagged, bulk and liquid feed to monitor the distribution of 966,334 tons of registered commercial feed in 1976. Official samples of 2,917 commercial feeds were collected for laboratory analysis to determine if product guarantees were being met. Laboratory analyses were made for 37 different feed components for a total of 9,631 laboratory findings. This total included 2,712 crude protein, 660 urea, 280 fat, 2,497 fiber, 519 calcium, 275 phosphorus, 446 salt, 357 trace mineral, 20 pesticide residue and 1,585 drug and antibiotic determinations.

In a cooperative program with the Federal Food and Drug Administration, the Division conducted 218 inspections of feed mills to determine compliance with Good Manufacturing Practice (GMP) Regulations for Medicated Feed. Kentucky has approximately 300 commercial mills which manufacture custom mix and/or registered medicated feed. The GMP Regulations require feed manufacturers to employ adequate production and control procedures in the manufacture and distribution of medicated feed. This helps to ensure that medicated feeds are both safe and effective for the consuming animal and safe for the consumer of livestock products.

Information presented in this bulletin was compiled from data collected from analysis of official feed samples taken during 1976 and is intended to provide the feed purchaser with knowledge as to the manufacturing standards maintained by feed manufacturers distributing feed in Kentucky. The intent is not to indicate feed quality but to show the frequency a feed manufacturer failed to meet the guaranteed analysis for one or more feed components.

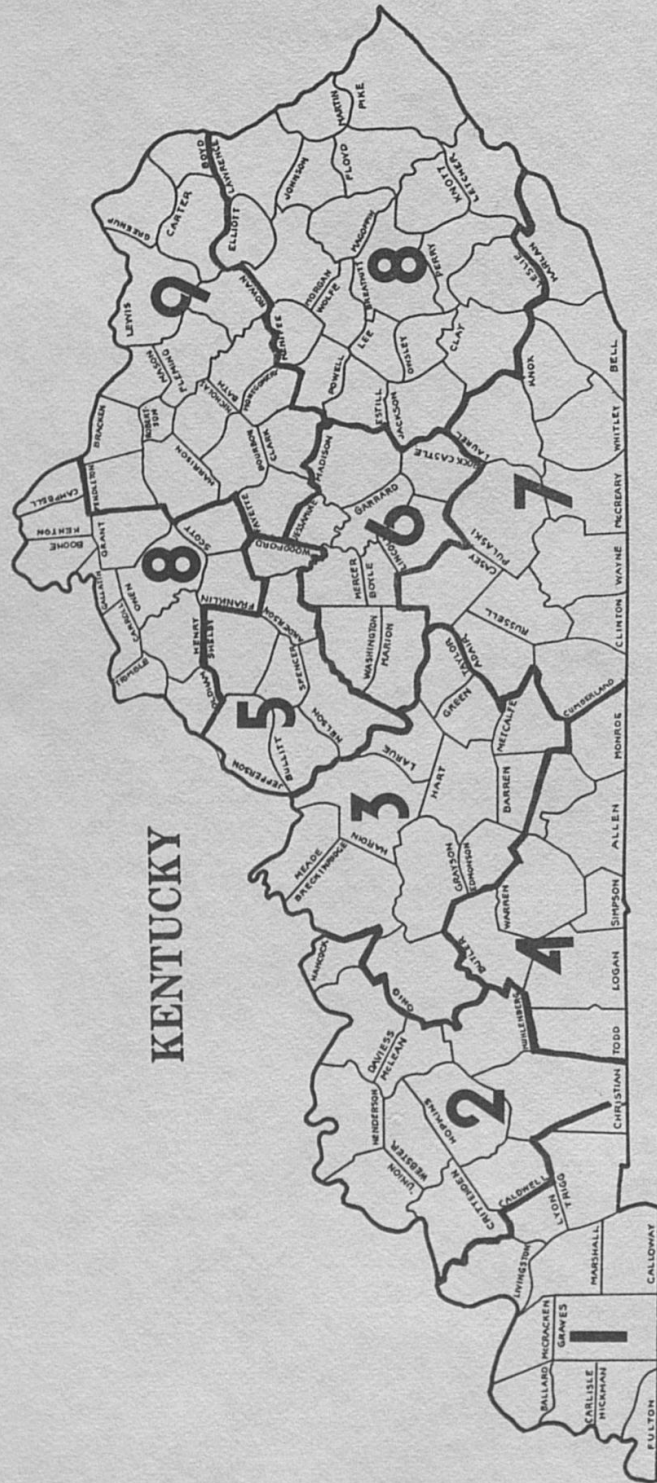
