PREFACE

In its compilation of Inventories of Archives of the Counties of Tennessee, the Federal Historical Records Survey in Tennessee, and its successor, the Tennessee Historical Records Survey Project, found it necessary to refer to the Acts and Codes of Tennessee by the device of abbreviated titles. The value of a check list of the volumes of the Acts or Session Laws of Tennessee and of the Codes was obvious both as a bibliographical reference as well as an explanation of the Tennessee Survey Project's symbols. Particularly, for these reasons, and because it knew of no similar list of full titles ever issued, the imprints unit of the Tennessee Survey Project undertook the preparation of this book. It is therefore issued as one of the special publications of the Tennessee Survey Project, designed to make available worthwhile and valuable materials substantially as they appear in the files, materials which, under original plans, would not have been made available generally.

The symbols or abbreviations used in publications of the Tennessee Survey Project have been indicated in this book together with the full titles of the volumes. This check list has been prepared in two chronological sections: the Acts of Tennessee from 1792 to the present, and the Codes from 1803 through the 1939 supplement. Each volume listed has been described from its title page, the title transcribed exactly as it appears. Nearly all of these volumes can be found in the Tennessee State Library and the State Office of the Tennessee Survey Project, at Nashville; and many of them in the holdings of Lawson McGhee Library, Knoxville; the University of Tennessee, the Library of Congress, and Harvard Law School Library.

The printers of the State have varied both in their choice of title-page descriptions and in the physical make-up of the Acts passed by the General Assembly. For convenience of research, the Tennessee Survey Project has used the symbol "Acts" with its date to indicate those volumes which contain both Public and Private or Local Acts but make no distinction between them. Those volumes with a title page reading "Acts", but containing the Public and Private Acts separated by a half-title or caption title are designated by "P.A." (Public Acts) and the date and "Pr.A." (Private Acts) and the date. If these volumes are found bound together, that fact is so indicated. Volumes whose title pages describe only the Public Acts, but which contain the Private Acts are designated with the words "and private" in brackets. Of the Codes, only those of 1858 and 1932 were enacted by the General Assembly of Tennessee as the Official Codes of the State. The symbols of the Codes are indicated by "C" and the date, while supplements are indicated by "C" and other letters usually standing for the author's initial. An exception to this practice is the symbol for Michie's 1932 Code published in the same year as the Official Code. Each volume of the Acts and Codes is described fully as to pagination and size, as well as title. The use of three dots in some titles indicates the omission of the volume number, or titles of the compiler.

The preparation of the check list was instituted during the administration of T. Marshall Jones as State Supervisor of the Survey Project before he resigned to become State Supervisor of the Research and Records Section of the Division of Professional and Service Projects. The collection of information for this bulletin and its preparation for publication were under the supervision of George F. Bentley, Imprints Editor of the Tennessee Survey Project. It was edited by Robert Cassell, Manuscripts Editor of the Tennessee Survey Project.
