Feb. 6, 1914

The Faculty of the State University of Kentucky met in regular session in its room in the Gymnasium building, Feb.6, 1914, those present being: Professors Boyd, Brown, Brumage, Carrel, Dantzler, Davis, Freeman, Garman, Gilbert, Gillis, Gullion, Miss Hamilton, Professor Healey, Judge Lafferty, Professors Mathews, Maxson, Melcher, Miller, Noe, Norwood, Rees, Rowe, Miss Sweeny, Professors Terrell, Terrell, Tigert, Tuthill and Zembrod.

In the absence of President Barker, Judge Lafferty presided. The minutes of the last meeting were read and approved.

Reports from the various Standing Committees being called for, Professor McHenry Rhoads, Chairman, made the following motion as a result of a meeting of the Committee on Accredited Schools from the Association of Kentucky Colleges; viz., That graduates of Accredited Schools, maintaining the four-year course in English, five recitations per week, who have completed the entire course, be given four credits in English instead of three.

This motion was seconded and unanimously carried.

Professor C.J. Norwood, Secretary of the Committee on Courses of Study, made the following report relative to the arrangement of names in the catalogue:

Resolved, That the names of the faculty of the State University of Kentucky be arranged in the Catalogue in the order of the date of appointment to the position under which their names appear. In event that members of the faculty have left the University for a period of service in other institutions of equal rank, this service should be considered as equivalent to the same length of service in this institution, so far as determining rank in this University. That the same rule should be observed in arranging the names of the Deans, position in the list being governed by the date upon which each one was named as Dean.

The Committee then arranged the names of Professors and Deans in accordance with the foregoing resolutions, as follows:

The matter of arranging the names of the Associate Professors, Assistant Professors, Instructors and Assistants was referred to Registrar Gillis, with instructions to follow the rule adopted with reference to Professors.

A motion was made, seconded and unanimously carried to adopt the report.

The Committee on Discipline next reported that

Mrs. Marshall had expressed a desire to be present when matters

of discipline or questions concerning the boys were brought up

before the faculty.

Motion was made by Dr. Terrell, seconded by Dr. Kastle, that Mrs. Marshall be invited to come before the faculty whenever she desired to make any statement concerning business pertaining to her work in the dormitories.

The motion was carried unanimously.

When the question of Entertainments Non-athletic was

brought up, Dr. Tuthill stated that there seemed to be too many night meetings during the week, resulting in the students coming to classes next day unprepared.

Motion was made by Dr. Tuthill, seconded and unanimously carried, that the question of class work incident to the number of night meetings during the week, be referred to the Committee on Student Welfare.

On behalf of the Committee on Student Organizations,

Dr. Pryor made a report, which, after some discussion, led to
the following motion: That sororities be informed that no
Freshman or Sophomore will be permitted to reside in Sorority
Houses, and that Juniors and Seniors must get permission from
the Dean of Women before doing so.

The motion was seconded and unanimously carried.

Professor Miller reported that at a meeting of the faculty of the College of Arts and Science to consider a change to the semester plan, it had been the unanimous verdict that permission be asked of the general faculty to make the change this coming year. They had discovered, however, that this action if adopted, would seriously interfere with certain classes in the Agricultural College -Botany, Etymology, Zoology, etc. - and consequently would not submit the question without Dr. Kastle's permission. Dr. Kastle asked for time to consider it.

President Barker being absent, he left a resolution to be read by the Secretary of the Faculty, which, after some general discussion and slight amendment, was adopted. It reads as follows:

BE IT RESOLVED by the Faculty of the State University, Lexington, Kentucky, that hereafter it shall be unlawful for any student to smoke in any of the recitation rooms, Y.M.C.A. rooms, Armory, Gymnasium, Drawing rooms, hallways, doorways or laboratories of the University; and that it shall be the duty of the professors, assistants and instructors and the Commandant to rigidly enforce this resolution.

For any violation of this resolution, the offender shall be summoned before the President of the University, the Commandant and the Dean of the College to which the student

belongs, who shall have power and authority to inflict such punishment as in their opinion the offense warrants.

A copy of this resolution shall be posted on the Bulletin, announced in Chapel and read by every instructor of the University in his classroom within ten days hereof, in order that the student body may be notified of this resolution. On motion, the meeting adjourned. En + Gills Secretary. President.
