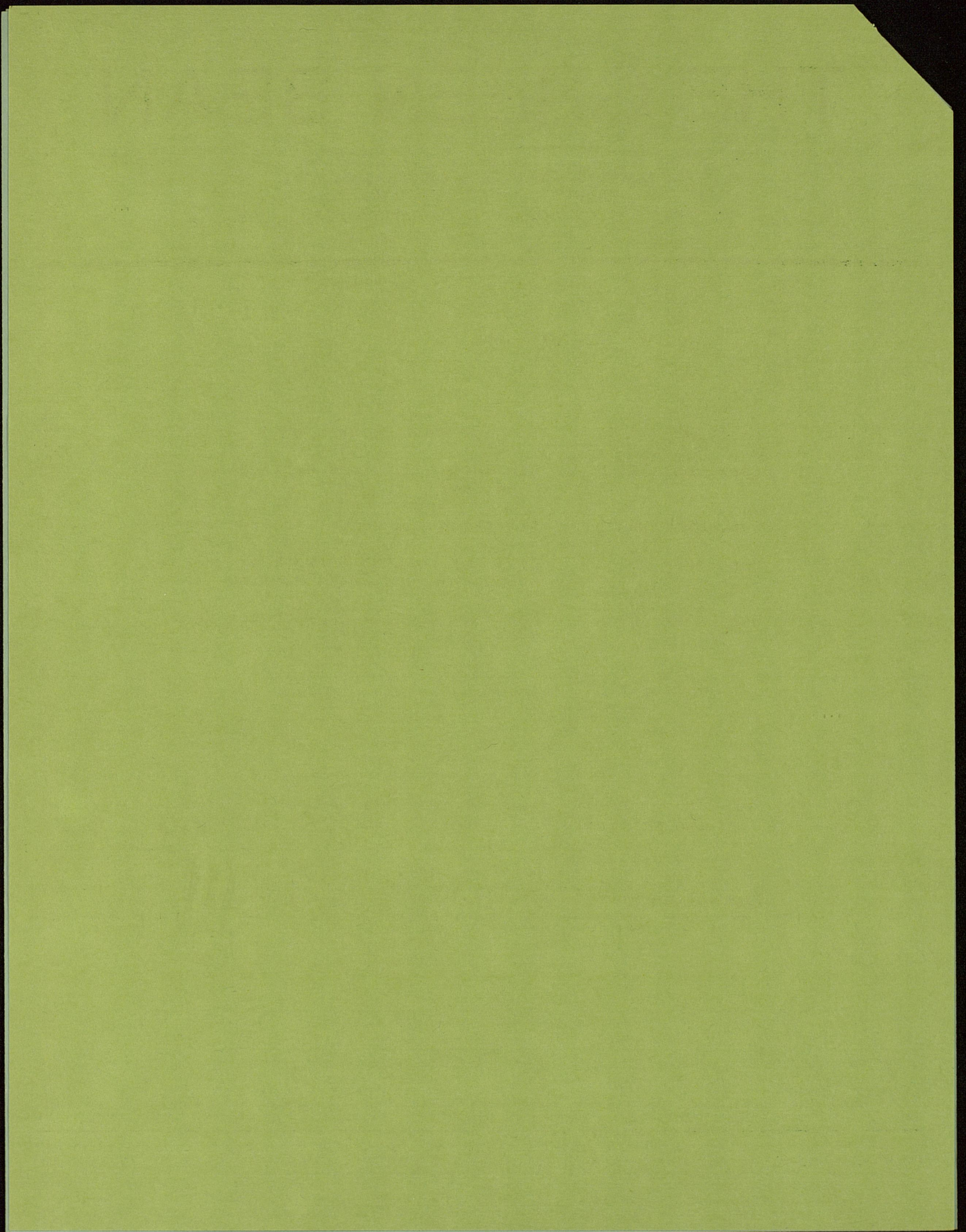

On behalf of the Modern Language Association, I would like to take this opportunity to acknowledge the work done by Mr. Michael Markiw of the University of Kentucky Libraries faculty as a volunteer contributor to the MLA International Bibliography.

As a contributor, Mr. Markiw analyzes and indexes journal articles, essays, and monographs on Slavic literature each year. Although this has always been a demanding and time-consuming responsibility, the implementation of a new indexing system for the Bibliography in 1981 has made it even more exacting. Thus, the dedication of the contributors has grown ever more essential to the production of each annual Bibliography.

Each year NEH awards several hundred summer research stipends to university faculty. The NEH not only considers projects in the traditional humanities disciplines but also funds projects in the social sciences that have humanistic content or focus. The

stipend is \$3,000 for two months of summer research.

This year the University will nominate three proposals for the national competition. Interested faculty members should prepare a proposal and submit it along with a curriculum vitae to Nancy Dye's office (217 P.O.T.) by Wednesday, September 18. Before applicants write their proposals, they should pick up a copy of the 1986 application guidelines (available in P.O.T. 217).
