The faculty met in regular session, April 8, 1916, quorum present. President Barker presided.

The minutes of the last meeting were read and approved.

The following recommendation from the Committee of Deans was adopted as read:

"That white and blue, the official colors of the University, should be arranged in the lining of the Academic Hood of the Oxford Gown, worn by candidates for a Master's Degree, according to what is technically known as parti-per chevron; that is, solid white above solid blue in the lining of the Hood."

On motion of Professor Anderson, action on the following recommendation was postponed one month and the Secretary instructed to furnish each member of the faculty with a copy:

"A special student, who has completed the college work pre-requisite to the senior year, may, if recommended by the faculty of his college for this privilege, be classified as a regular student upon either of the following conditions:

1 - If at least seventy-five per cent of his work is of "A" and "B" grades, his college credits may be substituted at the rate of two semester credits for each entrance credit not yet satisfied. At least twenty semester credits, whether used to satisfy entrance conditions or for graduation, must be selected from the subjects taught in the College of Arts and Science.

2 - If eighty-five per cent of his work is of "A" and "B" grades, he will be eligible to senior classification.

In any event, the student must offer six semester credits in college English."

On motion of Dr. Kastle the following interpretation the time of governing senior examinations was adopted:

"Senior examinations shall be arranged for two weeks in advance of the regular examinations of classes for this term".

" It is the sense of the Committee that these Senior examinations are intended to comprise all subjects, obligatory, elective or conditional, provided they are requisite for a Bachelor's Degree. "

REPORT OF SPECIAL COMMITTEE.

"Your Committee, appointed to consider the question of law students being required to drill, offers the following resolution:

Resolved - That it is the sense of the Faculty of the University of Kentucky that the law students matriculated in the four-year course should be required to drill, but the whole question of the assignment of drill to students in the College of Law shall

be left to the Dean of the College of Law with power to act in every case."

The Secretary of the Faculty reported that E. T. McClure, senior in the College of Agriculture had failed to remove his condition in English III and it was necessary to have permission of the ^{General} Faculty before he could be given the second examination. It was also reported that Lawrence Heyman, senior in the College of Arts and Science, had failed to remove his condition in Logic at the regular time for such examinations. On motion of Professor Anderson it ^{was} voted to refer these two cases to their respective faculties with power to act.

The following recommendation read by Dr. Mackenzie from the Graduate School was adopted:

"Resolved - That the General Faculty of the University of Kentucky recommend Hon. Augustus Owsley Stanley, Governor of Kentucky, for the Honorary Degree of Doctor of Laws."

Dr. Mackenzie also reported that the enrollment in the Graduate School this year was 83 as compared with 56 of last year.

On recommendation of Dr. Mackenzie, Secretary of the Committee of Deans, it was voted that Arbor Day be changed from April 21 to May 5.

Professor Mathews, Chairman of the Discipline Committee read a partial report of their investigation of the use of intoxicating liquors by students. President Barker requested that they complete their investigation before making a formal report. Also to ascertain the faculty rules governing same.

The following petition from the Pan-Hellenic Council was referred to a General Committee composed of the Committee on Entertainments - Non-Athletic, Student Organizations

and Discipline; with Professor Zembrod as Chairman.

"Whereas, we, the members of the Pan-Hellenic Council, representing the eight National General Fraternities in this institution, are of the opinion that certain rules and regulations of the Faculty governing non-athletic entertainments, and also initiation eligibility, and

Whereas, the members of the various fraternities through their respective chapters have called upon this Council to present these grievances to the Faculty, and

Whereas, this Council exists for the purpose of effecting harmony among the fraternities in their relations with the Faculty, requiring as we do that a candidate for initiation shall not be deficient in more than one subject, having carried a minimum of fifteen credit hours, and

Whereas, the complaint of this Council appears well-founded and just,

NOW THEREFORE, be it respectfully resolved that the Faculty should modify said objectionable rules with the view of making them more acceptable and satisfactory to the parties concerned, and granting privileges as follows:

(1) Fraternity house dances, in view of the fact that only two are given by each fraternity annually and that considerable effort and expense are incurred, should not be closed until twelve (12) o'clock.

(2) That it may be the privilege of the fraternities to serve light refreshments if they so desire.

(3) Since there is no adequate place on the campus in which to give a dance, we seek the privilege of being permitted to give them elsewhere, properly chaperoned.

(4) Men having entrance requirements and carrying fifteen hours work shall be eligible to initiation.

(5) We would suggest that the Pan-Hellenic Council have representation on the Non-Athletic Entertainment Committee of the Faculty.

(6) Since fraternity houses are maintained for the purpose of accommodating our social activities, to a certain extent, we are of the opinion that more frequent house entertainments will have a tendency to elevate the plane of our diversions."
