# from industrious to industrial: untangling the snags along the way....

## How two Kentucky farmers became manufacturers with a little help from UK

When you work with wool, you expect a few snags now and then. But when two first-time inventors set out on the road to manufacture a new kind of wool processing machine, the snags multiplied. It's what they call a "learning experience." Or, as Lanette Freitag and Don Bowles put it: "Every time you think you're there, you're not there yet."

Luckily, you can also encounter some great assistance on that road to get you there at last.



For example, UK's Center for Manufacturing, where Tom Henninger used computer-aided design to help the couple re-design their machine, the FeltLOOM™, to be lighter, less expensive and easier to use. UK also built them three prototypes and provided them with a bill of materials, and the engineering and assembly drawings they needed to go into production.

# Presidential Conversation



## Talented Students At UK

*"If there is any one secret of success, it lies in the ability to get the other person's point of view and see things from that person's angle as well as from your own."* – Henry Ford

I think it's always healthy for an organization to step back and analyze how it has been serving its customers/constituents. Over the years, I discovered that the most successful organizations — those that grow, thrive and continue to compete in an ever-changing global economy — are constantly working to make sure they provide the best and most effective service to their customers.

During the summer, I did a great deal of thinking about how the University of Kentucky can better serve the people of Kentucky. I realized that our students, faculty and staff are engaged in many projects that are improving lives across the state, but I have not spent enough time touting their efforts. Over the coming year, I will use this space to feature our innovative students, faculty and staff who are working to change conditions across the Commonwealth, the nation and the world.

As we welcome our newest members of the UK family to campus this fall, I want to take a moment to tell you about a pair of our recent graduates. Ryan Quarles, a second-year law student at the UK College of Law, has been awarded the Zuckerman Fellowship from Harvard University. Only 25 are awarded annually and are geared toward students entering public service who are pursuing a professional degree along with one of Harvard's education, public health or government programs. Ryan will pursue a graduate degree in higher education, focusing on postsecondary legal and funding issues as well as other contemporary topics. The fellowship gives him the opportunity to take classes at Harvard Law School and the John F. Kennedy School of Government. Ryan is from Georgetown, where he grew up on his family farm. He completed a triple-major undergraduate degree at UK, a master's degree in diplomacy from the Patterson School, and a master's degree in agricultural economics from the College of Agriculture.

Another top UK scholar, Whitley County's Andrew Lynch, will take what he learned at UK to another of the world's premier universities. Andrew established himself as one of the nation's top scholars while earning his undergraduate degree in chemical engineering at UK by being named a Beckman, Udall, Goldwater, and Astronaut Scholar. To top it off, Andrew was named UK's first-ever Gates Cambridge Scholar last spring. He received one of only 45 scholarships from the Bill and Melinda Gates Foundation, which will allow him to pursue his Ph.D. in chemical engineering at Cambridge University in England.

Both students are great examples of the type of talent that exists in this state and the type of top-notch students that are choosing to come to the University of Kentucky. Ryan and Andrew also are ideal role models for our incoming freshmen, as they show our students what worldwide opportunities await them if they succeed here at UK.

I hope you, too, share these UK success stories with your friends, family and neighbors. Our alumni are often our best ambassadors and student recruiters, and I hope you will help us share your UK experience with a new generation of upcoming alumni.

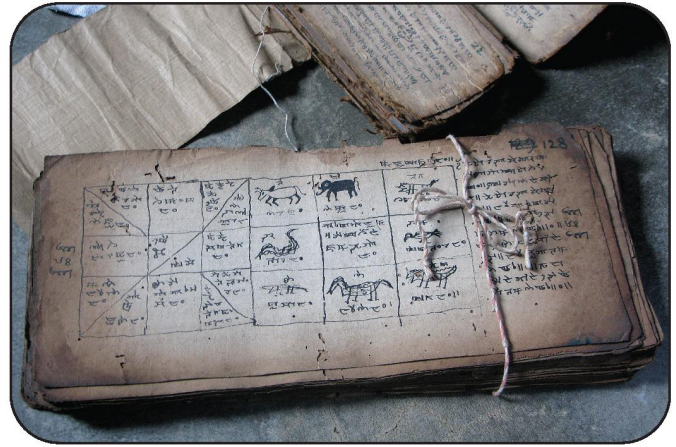

## Ashland Inc. – Spears Law Professor

Robert G. Schwemm is the first Ashland Inc.–Spears Distinguished Research Professor for the UK College of Law. His five-year term began July 1. Selection of Schwemm was based on a history of excellence in scholarly achievement and his promise of excellence in scholarly achievements during his five years in the professorship. He has taught at the College of Law since 1975, focusing on civil procedure, constitutional law and civil rights.

The professorship is named for Richard W. Spears, UK Law '61 who joined Ashland in 1964 and rose to senior vice president. He promoted education in Kentucky and established student scholarship. He died in 2007.

## Chellgren Center Names Endowed Professors

UK professors Jonathan Golding and Bill Rayens have been named Chellgren Endowed Professors, in affiliation with the Chellgren Center for Undergraduate Excellence. These professorships are tenable for three-year, nonrenewable terms, during which the Chellgren Professors will work on projects that are intended to promote excellence in teaching and learning at UK.

Jonathan Golding, professor in the Department of Psychology, is a specialist in memory processes (most notably intentional forgetting) and in psychology and law (most notably jury decision-making). Bill Rayens, professor in the Department of Statistics, focuses his research on the development and deployment of "structure seeking" multivariate paradigms.

## University Press Launches Podcast Series

University Press of Kentucky (UPK) has launched the Dark-Horse Podcast Series, a new video podcast series that features in-depth interviews from authors of books published by the press. Viewers now have the chance to hear scholars from such fields as philosophy, popular culture, film and Kentucky writing while gaining insight into the writer's side of the publishing process from a creative, alternative medium.

The first podcast of the series features author Thomas R. Lindlof discussing his most recent work, *"Hollywood Under Siege: Martin Scorsese, the Religious Right, and the Culture Wars."* Lindlof is a telecommunications professor at the School of Journalism and Telecommunications in the University of Kentucky College of Communications and Information Studies.

## Prof Enters Drum Corps Hall Of Fame

James Campbell, a Provost's Distinguished Service Professor and director of Percussion Studies in the UK School of Music, is one of only four drum corps legends to be elected into the Drum Corps International (DCI) Hall of Fame for 2008. The DCI Hall of Fame is where the legends of drum corps activity are remembered for the indelible impressions they have left on the drum corps world.

Campbell is responsible for much of the modern look and sound of today's drum corps percussion ensembles. As an equipment designer, he also has helped design the modern tenor drum array, holds two patents for drum head design, and pioneered the use of the front ensemble (pit) percussion.

An official ceremony will take place in January in California.

# Research Notes

## Prevention, Treatment Could Curb Meth Problem

A two-year, comprehensive report commissioned by UK President Lee T. Todd concludes the popular perception of a “meth epidemic” tends to overstate the role of methamphetamine in the overall picture of substance abuse in Kentucky. Alcohol, marijuana and prescription opiates are the state’s biggest and most costly drug problems. More attention to treatment and research could lead to saving tax dollars.

Sharon Turner, dean of the College of Dentistry, and Robert Walker, assistant professor in Behavioral Science, formed a group of researchers, clinicians, and other experts to examine Kentucky’s emerging substance use problems. The report suggests the state could save millions of dollars in law-enforcement, health care, child welfare and prison costs by investing in research and improving drug-abuse awareness, prevention and treatment.

## E.ON Awards Grant To UK Energy Center

Energy storage may very well hold a key to expanding renewable energy and managing peak demand. Kentucky just proved that it has one of the world’s leading research centers on the topic as the UK Center for Applied Energy Research (CAER) was among 10 international universities and institutes that won a total of 6 million euros (approximately \$9.4 million) in the 2007 E.ON International Research Initiative competition conducted by E.ON AG’s of Dusseldorf, Germany.

CAER netted nearly \$1.2 million to further research how to store energy using asymmetric carbon-based electrochemical capacitors instead of batteries, as has been done previously. Capacitors can handle very rapid charging and discharging over hundreds of thousands of cycles.

Storing energy could make renewable energy more accessible in areas like Kentucky, where the wind doesn’t always blow and the sun doesn’t always shine. Additionally, energy storage could help energy companies manage peak demand more effectively.

## Literacy Program Shows Success

A recent report issued by the U.S. Department of Education, Institute of Education Sciences stated that the Reading First national literacy program was not having a statistically significant impact on student reading achievement. However, the Collaborative Center for Literacy Development (CCLD), which is housed in the UK College of Education, reports that the opposite is true in Kentucky.

Research conducted by the CCLD shows that in the 72 schools across the Commonwealth of Kentucky that are participating in the Reading First program, reading growth has been seen across the board. In the first four years of the five-year program, the percentage of students in kindergarten through third grades proficient in reading has increased 30.1 percent to 71.7 percent (from 2004 to 2007). Also, in these schools, the achievement gap between white students and other racial groups is narrowing. For example, Caucasian students have improved 14.7 percent while African-American students have improved 28.8 percent.

“Rather than using one standard package of materials statewide, Kentucky’s proposal for the Reading First grant is based on meeting the needs of individual schools and students,” says Susan Cantrell, CCLD executive director. “The Kentucky program is grounded more in professional development and teacher learning than in just implementing scripted packaged programs.”

Reading First was established by the national No Child Left Behind Act of 2001 to help all children read at or above grade level by the end of third grade. In 2009, a final report will be issued.

## UK Wins \$10 Million NIH Superfund Grant

UK has received a grant of more than \$10 million for a multi-pronged effort to study the relationships among environmental pollutants, nutrition and disease. Funded by the National Institutes of Health (NIH), the grant will support the efforts of more than 50 scientists and students representing more than 15 academic departments in the colleges of Agriculture, Arts and Sciences, Engineering, Medicine and Pharmacy.

UK’s program, “Nutrition and Superfund Chemical Toxicity,” was one of only two proposals selected for funding from among 18 competing grants submitted nationally to the NIH’s National Institute of Environmental Health Sciences under its Superfund Basic Research Program. Superfund sites are defined by the U.S. Environmental Protection Agency as uncontrolled or abandoned places where hazardous waste is located. There are more than 500 such sites in Kentucky, a state in which rates of such chronic diseases as cardiovascular disease, cancer, diabetes and hypertension are well above national averages.

The grant will support five projects that address ongoing Superfund-related issues in the Commonwealth. Three of these projects focus specifically on biomedical issues while two nonbiomedical projects tackle chemical detection and clean-up.



# »»» Keeping A Watchful Eye:

Brian Cury combines his love for movies with fascination for computers.

**F**locks of sunlight glisten on the steely blue waters off of Waikiki Beach in Hawaii. Hundreds of people swim in the ocean and walk along the sand, enjoying the perfect 84 degree day. As slender palm trees sway in the breeze and the tide laps at the shore, it's obvious why they call this land paradise.

*Click*

A horse-drawn carriage moves slowly through the jammed intersection of St. Peter and Bourbon Streets in the New Orleans French Quarter. Tourists pass in front of the famous Cat's Meow, the U.S. birthplace of karaoke. As the night gets later, the crowds get thicker and the Big Easy shows once more why "laissez le bon temps roulet" is the city's mantra.

*Click*

In northern Arizona, the Chapel of the Holy Cross juts out from one of the buttes of Sedona. Standing some 250 feet above the valley, the chapel is literally wedged in the red rock. The marvel of its architecture is rivaled only by the sense of awe it inspires and the beauty of the surrounding flat bluffs.

*Click*

Where do *you* want to go? The barrier islands of South Carolina? Trafalgar Square in London? Or how about the historic city centre of Prague? Whatever destination whispers to you, there's a good chance that 1981 University of Kentucky graduate Brian Cury can take you there.

With a click of your computer mouse, Cury's company, EarthCam Inc., makes it possible for you to visit places you might not ever get to see in person. Live feeds over the Internet bring exotic locations right into your living room and even to your mobile phone.

But that's only one part of EarthCam. A major and rapidly growing revenue stream at the New Jersey-based operation comes from selling technologies to international industries and government agencies, for everything from documenting large construction projects to providing real-time traffic data. The third segment of the business speaks to the changed world since September 11, 2001: EarthCam provides security cameras to cities and corporations in the United States and beyond.

When Cury created his company in 1996, he meshed his love for movies, his admiration for Hollywood innovators and his fascination with computers. At a time when many were still trying to figure out exactly what the World Wide Web was, Cury recognized that the Internet was the next great frontier. He established EarthCam in 1996, pioneering the Webcam industry. Today the company is recognized as the leading international technology and product provider of Internet-based Webcam monitoring.

## Love at First Sight

It would be fair to say that Cury has watched the world through the lens of a camera for most of his life. Beginning when he was just a child growing up in New Jersey, he made short films with an 8mm camera. In those days, he knew two things for certain: movies were his favorite hobby and one day, he would attend UK.

Family ties brought Cury's father, Buddy, and brother, Bruce, from Brooklyn, N.Y., to the Commonwealth, where they attended UK. Cury also has other family members who attended UK, he says, including cousins and aunts and uncles.

"It was a family tradition," Cury says. "While growing up, I was told that I was going to the University of Kentucky." Cury's first

visit to the campus was at freshman advising. "A few weeks later, I was on a plane to Lexington."

Initially, Cury majored in computer science, but after explaining his interests to the dean of the College of Arts & Sciences, Cury was able to thrive with a more customized academic track in film and television, making the dean's list.

From there, it was on to graduate school at New York University. After stints with "Saturday Night Live" and MTV Networks in various capacities, Cury created his own television production company. His goal of making movies and TV shows was on track, except for one thing; he realized he needed a business where he had more control over the finished product. In television, there were too many other people determining his future. So he turned his focus to technology and EarthCam was born.

## Altered Paradigm

"A lot of things changed in my business after 9/11," Cury says. Prior to then, his company focused on entertainment work, such as shooting behind the scenes at Superbowls. When the United States was attacked in 2001, it created a shift in who wanted to use cameras and how.

Promoting an event became less important than protecting lives. Travel became more cumbersome, so corporations looked to cameras to monitor and manage construction projects. Government officials turned to EarthCam and its technology to keep critical infrastructure, such as tunnels and bridges, safe.

Cury doesn't disclose sales figures, but if the list of EarthCam's clients is any indication, business must be very good. WalMart and Walgreens use EarthCam equipment at the sites of their new locations under construction. Coca-Cola, Panasonic and Prudential hired the company to monitor their massive billboards in Times Square. Disney contracted with EarthCam to view live and record the filming of *"Pirates of the Caribbean: Dead Man's Chest"* and *"Pirates of the Caribbean: At World's End."* Today EarthCam equipment is transmitting and recording live images of Paramount's *"Transformers 2"* currently in production on a remote desert location.

Both the New York Giants and the Orlando Magic purchased EarthCam technology to not only document the building of their new facilities, but also to provide status reports to devoted fans. Jet Blue Airlines has EarthCam cameras in place as its terminal at New York's Kennedy Airport is being completed. NASA has EarthCam recording space shuttle landings. Other customers include the Dubai International Airport, Las Vegas casinos and state departments of transportation. EarthCam also is monitoring the rebuilding at Ground Zero.

Some of this technology also has come to the UK campus. Currently, there are 15 EarthCam cameras in operation at UK. They range from those at the Johnson Student Recreation Center, various parking structures and student dorms, and the Patient Care Facility currently under construction. Two others that were donated by

Cury are waiting on additional funding for installation. This includes one that's referred to as the "Mom Cam" where students will be able to rendezvous with their parents and friends for a real-time "hi!"

Ed Steverson with the university's facility planning department was the first to suggest the idea of Webcams. After purchasing cameras from another outfit that provided no customer support, Steverson contacted EarthCam for help. He didn't know that a UK graduate was the president of the company. When Cury learned that it was his alma mater on the phone, he took over personally, lending his company's knowledge and expertise to get the cameras up and running — all at no charge. That was the start of a strong business relationship that has lasted for some nine years.

"These guys are industry leaders," says Steverson.

## On Guard

Of course, as the demand for cameras has grown, so have the privacy concerns.

Cury responds to those concerns by stressing that his company's Webcams are mounted in very public places. "You don't have an expectation of privacy," in an area like Times Square, says Cury. "It's not like we're zooming in on people and following them around the streets." Instead, he believes these "slices of life" help improve understanding by showing people around the world what another society looks like.

As for the security cameras that EarthCam installs, Cury says the technology is a way to protect citizens, property and investments. "People need to understand that it's a new world out there. The reality is that we don't have the next door neighbor watching

like we used to have years ago,” he says. Now, cameras are used and in the process, they safeguard jobs, enable cost and time-saving management of major construction projects, and most important, can save lives.

Cury also points out that security cameras are much more common in other countries. For example, there are approximately 6,000 cameras currently operating in New York. That contrasts

with more than 400,000 in London, part of more than four million throughout Britain.

## New Technology/Old School Values

For a man who makes his living from creating and using the latest technology, Cury is amazingly old-school about certain things. He loves classic movies like *“Casablanca”* and *“Citizen Kane.”* He respects the genius of legendary directors such as Woody Allen, Stanley Kubrick and Ingmar Bergman. He believes in passion for the work, whatever that work is. He worries about whether the technical and programming skills of recent graduates are adequate.

And if this bachelor ever has children, they will go to UK, just like their father and grandfather before them.

That loyalty to UK is because of his own experience on campus. He remembers former theater professor John Lynaugh who cared about films as much as Cury did. “He made me excited about theater, about being passionate about the art and about the craft. I respected that.”

Cury recalls another former professor, Charles Dickens, as “interesting and articulate.” Dickens also stands out in his memory because he was in *“The Estate,”* a movie that Cury wrote and shot in his senior year at UK. “There was so much that I learned at UK that still helps me in business today,” he says. “I loved it.”

When Cury was a kid growing up during the Apollo moon missions, he wanted to be an astronaut. Now, his company travels through space and time, providing a bird’s eye view of the world to the world. And the man who dreamed of making movies and television shows, now uses the world as the stage, everyday people as the actors and the Internet as a theater for billions.

## Brian Cury Tidbits

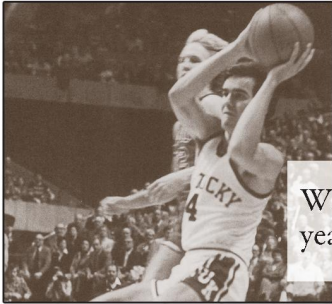
- Years ago, a couple asked Cury to videotape their wedding since he worked in film. He reluctantly agreed. While taping the traditional father/bride dance, he accidentally backed into the wedding cake and knocked it over. He never taped another wedding.
- Best movie he’s seen lately – Ingmar Bergman’s 1957 film, *“The Seventh Seal,”* which features a chess game between the movie’s main character and Death.
- After filming his comedy-murder mystery, *“The Estate,”* at UK and then later editing it at NYU, he returned to Lexington and premiered it at the downtown Kentucky Theatre.
- When Cury worked for *“Saturday Night Live,”* prominent cast members included Eddie Murphy, Julia Louis-Dreyfus, and Joe Piscopo. - Early in his career, Cury also served as manager for comedian Larry “Bud” Melman, a regular who appeared for years on both of David Letterman’s late night talk shows. Melman, who died last year, was known for his thick glasses, unpolished on-camera banter and silly skits.
- Cury refers to himself as an inventor and the description fits. He holds three patents, he says, all dealing with camera technology.

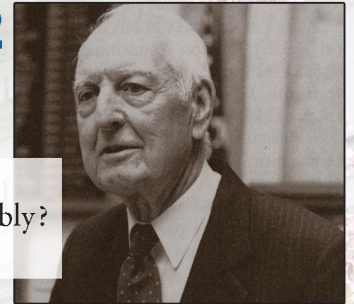

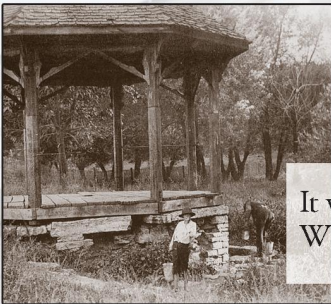

# Jamal Mashburn Scores in Transition

In the midst of living his dream of playing in the NBA, Jamal Mashburn was already looking ahead to the day when he would no longer be playing basketball. He realized early the importance of being prepared for life's inevitable transitions.

"I always realized that I wouldn't play basketball forever," said the former Wildcat great. "I didn't want to. I always planned for that day, so when it came, I think I was prepared to make the transition from basketball player to former basketball player."

Fortunately, when retirement came, Mashburn was ready for the next stage in his life. He joined ESPN and is currently working as a studio analyst for the network's NBA coverage.

Mashburn says the transition from player to analyst was smooth, much easier than he would have anticipated.

"I am actually in the process of writing a book about transitions — willing and forced — in life. I'm not using a ghost writer. I am writing it on my own. This process has not only helped me share my experiences with others, it also has helped me through my own transitions."

"Monster Mash" will always be adored by Kentucky fans. Mashburn humbly deflects credit to his former coach; however, his commitment to UK was a big part of the process of restoring Kentucky's basketball program after probation. Lexington and Rupp Arena were a long way from Holcomb Rucker Memorial Park Playground in New York City, where he grew up playing. Mashburn quickly learned that basketball in Kentucky is something special.

"I was a kid from inner-city New York," he said. "It really was a huge transition for me. I really didn't know that much about Lexington. I had no idea how big basketball was at Kentucky. Coach said, 'trust me.' And I did. It was definitely a great decision for me."

Mashburn says he has great memories of his time at the University of Kentucky.

"Whenever I look back at my career, of course, I enjoyed my professional career, but I think of my college career as the purest time for me playing basketball. We played it the right way and had a lot of fun. I have the highest regard for Kentucky. I met my wife there and I made some great friends."

He started the Jamal Mashburn Scholarship Award program just days after declaring himself eligible for the 1993 NBA Draft and before signing his first professional basketball contract. The endowment directly benefits young people in the Lexington community. Since the program was established, more than two dozen students from Fayette County high schools have participated.

"I am amazed at the quality students that apply for the scholarships. They are first-rate. The strength of the applicants really blew me away," he said.

Giving back has always been important to Mashburn.

"Getting a scholarship was huge for me.

Without basketball, I probably wouldn't have been able to attend college. I know that I was very fortunate that athletics provided a way for me. It is very important for me to give back. It is really a team effort. My mom (Helen Mashburn) is very involved. It's been a very positive experience."

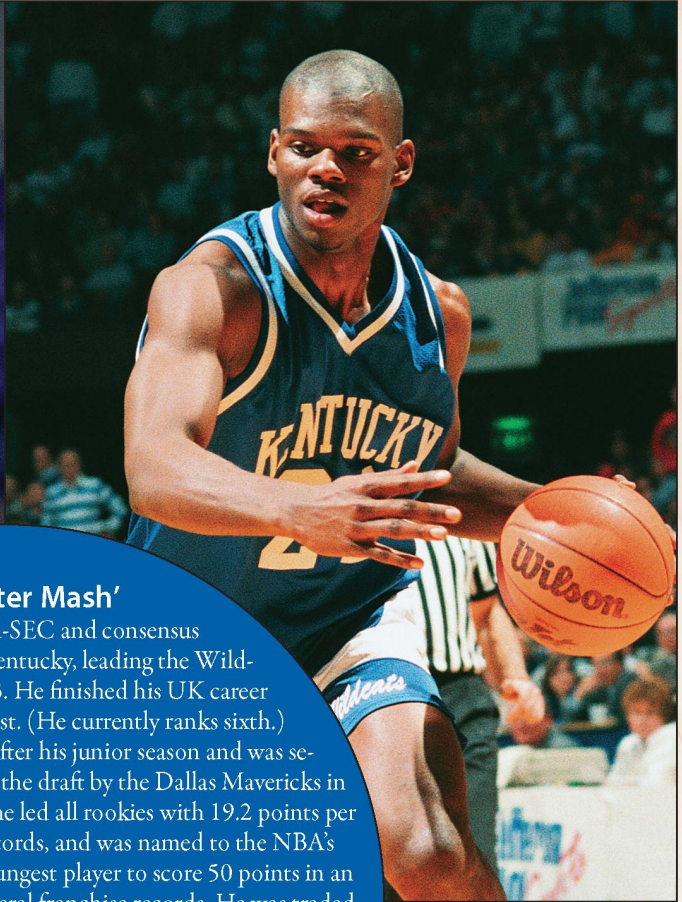
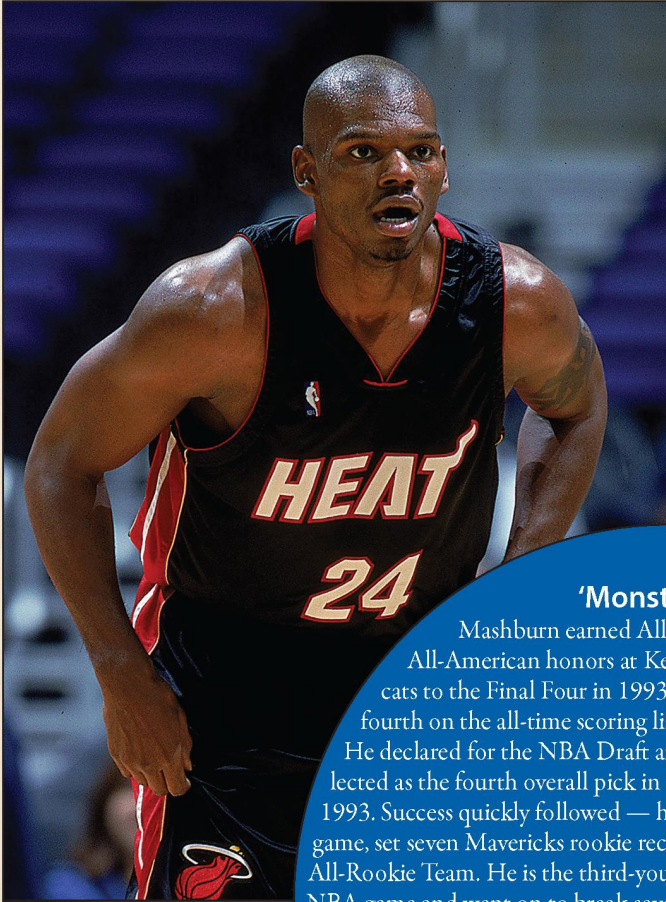
He is involved in numerous business ventures, including teaming with former Kentucky coach Rick Pitino and Rick Avare to form MAP (Mashburn, Avare and Pitino), which owns several businesses in Kentucky.

Mashburn and his wife, along with their two children, daughter Taylor, 11, and son Jamal Jr., 6, live in Miami, Fla. He is back in Kentucky a couple times a month due to his business interests.

A member of the Kentucky Athletics Hall of Fame and the UK Athletics Hall of Fame, he hasn't been bitten by the coaching bug so far.

"I have never really thought about it," he said. "I can coach my son. I love my son, so I have lots of patience with him. I don't think I would have the same patience with college kids or even professional players. I am interested in becoming an NBA owner someday."

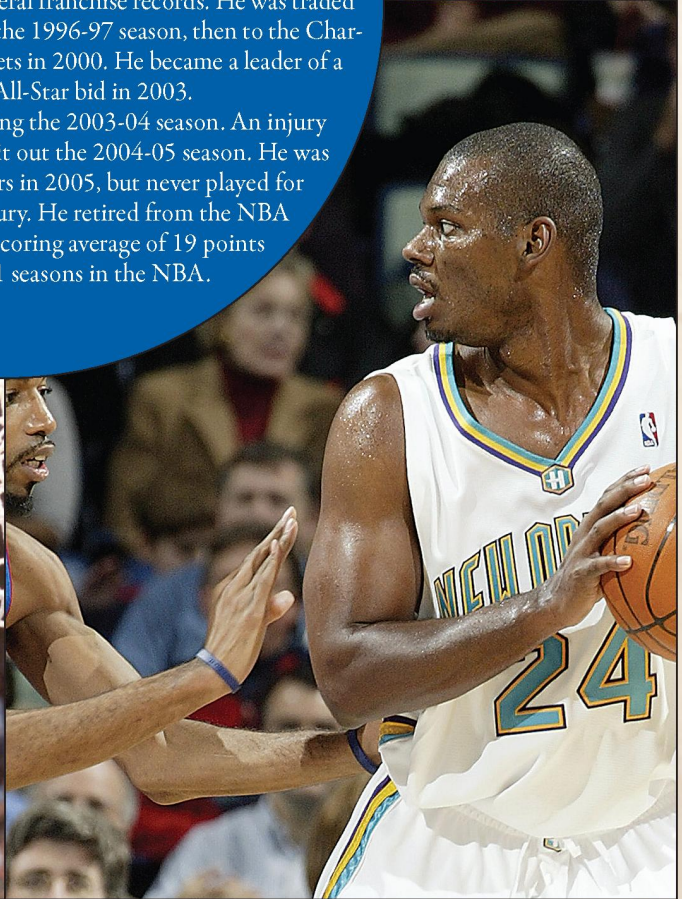
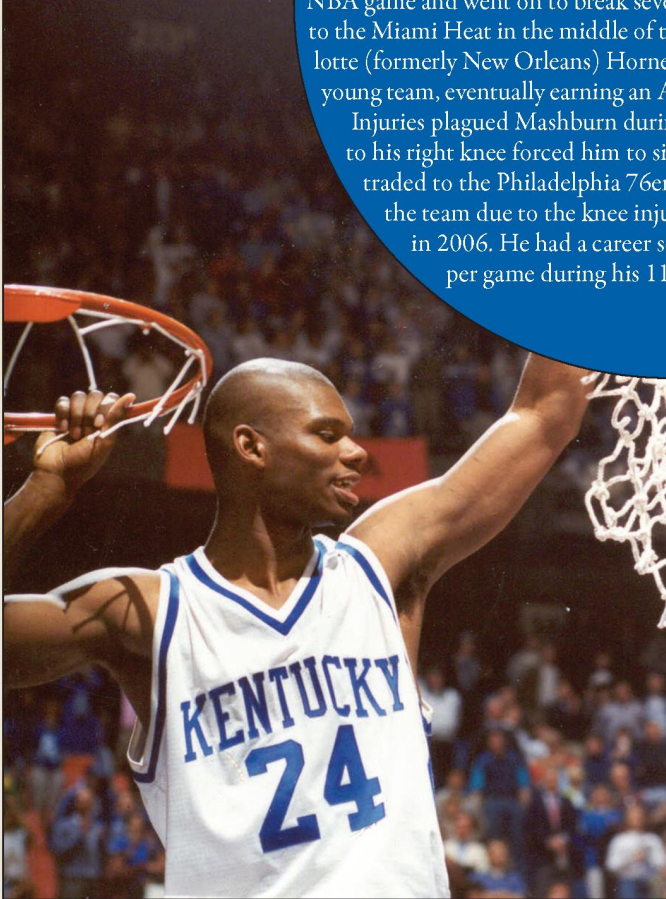




### 'Monster Mash'

Mashburn earned All-SEC and consensus All-American honors at Kentucky, leading the Wildcats to the Final Four in 1993. He finished his UK career fourth on the all-time scoring list. (He currently ranks sixth.) He declared for the NBA Draft after his junior season and was selected as the fourth overall pick in the draft by the Dallas Mavericks in 1993. Success quickly followed — he led all rookies with 19.2 points per game, set seven Mavericks rookie records, and was named to the NBA's All-Rookie Team. He is the third-youngest player to score 50 points in an NBA game and went on to break several franchise records. He was traded to the Miami Heat in the middle of the 1996-97 season, then to the Charlotte (formerly New Orleans) Hornets in 2000. He became a leader of a young team, eventually earning an All-Star bid in 2003.

Injuries plagued Mashburn during the 2003-04 season. An injury to his right knee forced him to sit out the 2004-05 season. He was traded to the Philadelphia 76ers in 2005, but never played for the team due to the knee injury. He retired from the NBA in 2006. He had a career scoring average of 19 points per game during his 11 seasons in the NBA.

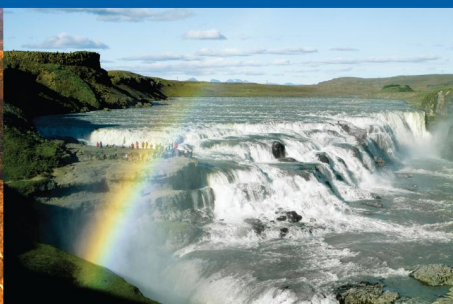
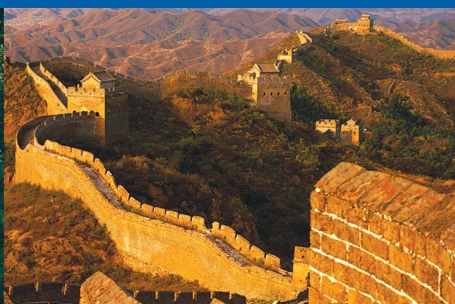

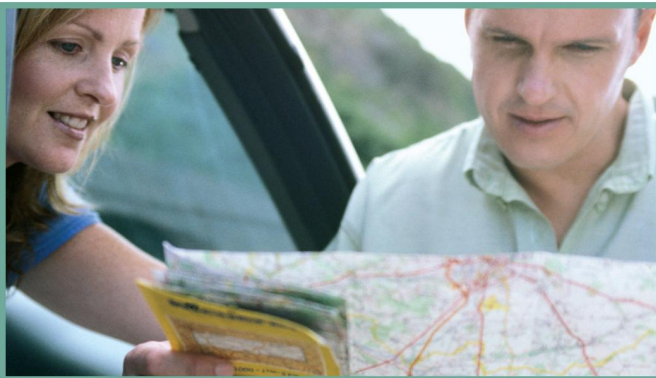

# Generations of Care

The Nitz family has been providing physical therapy (PT) rehabilitation to patients since 1954. This PT family legacy continues with the newest physical therapist in the family – Melinda (Mindy) Nitz – who graduated this year from the University of Kentucky with a master’s degree in physical therapy.

John Nitz, now a retired physical therapist living in Indiana, started the family trend. He was interested in the medical field and was training to become a coach when he took an interest in physical therapy. In 1954, John graduated from the University of Colorado with his PT degree and spent 40 years in the profession.

Arthur “Art” Nitz, John’s son and a full professor in the UK College of Health Sciences physical therapy program, later followed in his footsteps.

“My dad was always trying to tape us up,” says Art, who comes from an athletic family with six siblings. “He was always throwing around a football, playing baseball with us, or doing something active.”

As he grew up, Art began to admire the active role his father had played in their family and became more interested in a career as a PT.

“I liked the lifestyle that a physical therapy career allowed,” he said. “And I could see firsthand the value of rehabilitation principles through my own experience with sports and injuries.”

Art attended Baylor University and with the help of the U.S. Army, received his degree in physical therapy. He later was stationed at Fort Knox and soon became interested in scientific research. In 1984 Art earned his doctoral degree in anatomy at UK. In addition to teaching, he is also the owner of ProActive Therapy in

Frankfort and Versailles, a physical therapy clinic that employs more than 35 people.

Like her father, Mindy is an athlete who also values family.

“I really like the relational side of physical therapy,” Mindy says. “You get to know your patients on a personal level and really help them get back to life — whether that is playing sports, gardening, or just living.”

Although some students might have a problem taking a class led by their father, Mindy was the opposite. In fact, the program at UK was the only one to which she applied.

“My mom homeschooled us and my dad taught us Latin at 6 a.m. two days a week,” she says. “I’ve always been used to learning from my parents.”

Mindy now works at the Ireland Army Hospital, Fort Knox, Kentucky.

Art and his wife, Jane, have five children and reside in Frankfort. Their youngest child is in eighth grade and plans to keep the family tradition going by working in hippotherapy, which focuses on the movements of a horse in therapy and rehabilitation techniques.

# Profiles in BLUE Janie Olmstead

For over 30 years, Janie Olmstead and instructors at her Lexington firm, Images Model & Talent Agency, have helped individuals, young and not-so-young, gain confidence and begin their careers.

Olmstead, who earned a bachelor's degree in physical education from UK in 1966 and a master's in guidance counseling in 1968, took the idea she had to help people excel and grew it into a respected businesses for training individuals who want to pursue a print, film, or stage career. Her company won numerous awards, including International Modeling School of the Year in 1994, 1995 and 1996 from the International Modeling & Talent Association. Images was inducted into its Hall of Fame in 1997.

She grew up in New Castle (Henry County), back then a small town of only 700 people, where her father was mayor. "He won by one vote one year," she said.

As a teen, she took modeling classes with Ruth Devine who was with the Alix Adams Agency in Louisville. Devine encouraged her and later acted as her chaperone when Olmstead was Miss Kentucky in 1966, just after she graduated from UK.

Olmstead was a school teacher and a guidance counselor in Virginia and Kentucky. When she and her late husband were living in Frankfort, she started her modeling school for teens and young adults in a dance studio she rented over a bakery. "I wanted my students to learn self-confidence," she said. "I sat down one night and wrote a curriculum and then I borrowed \$500 from Farmers Bank to get started."

She eventually moved the business to Lexington, employing several full-time staff members and 10 part-time instructors who also train aspiring models and actors in such things as poise, voice and makeup. Pupils work as advertising models, but several have gained even more recognition, like Farah Fath, who plays Gigi on *"One Life to Live,"* and Jeremy Sumpter, a boy who played Peter Pan in the 2003 movie.

Olmstead doesn't equate television shows like *"America's Next Top Model"* to the same type of education her school provides to develop professionals. "They want quirky characters on the show, even combative personalities," she said.

Olmstead, who has two grown children, Julie and Bob, would like to keep the agency in the family but realizes that this goal might be a long-term one. "I might have to wait until my four-year-old granddaughter wants to take over. She's showing interest," she said.

4. Have shown evidence of actual merit of work in their chosen field of endeavor and community leadership.
5. Not be the holder of an elected political office.

Nominations should include:

1. This completed form.
2. Maximum one page letter highlighting why you think the person should be considered.
3. Maximum five additional pages supporting the above criteria about each candidate's credentials, achievements, the impact of those accomplishments, public awards and honors, and outside sources such as published articles.

Nominations may be submitted immediately and will be accepted until December 31, 2008.

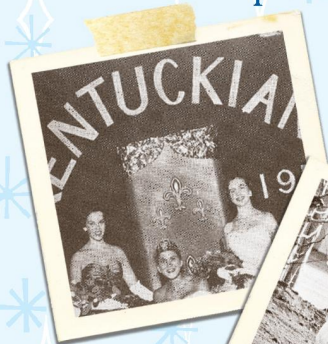

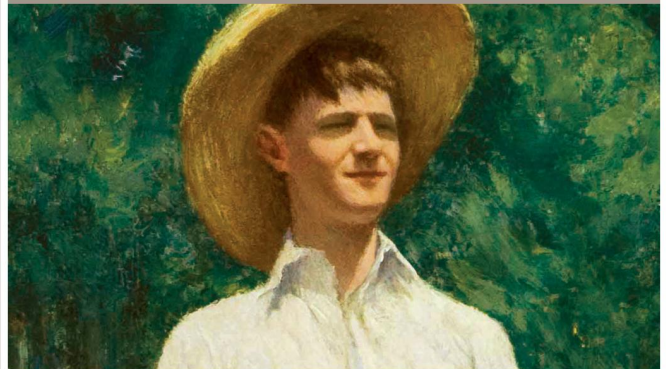



## Career Corner with Caroline Francis



### Alumni Career Services

There was plenty of fruitful activity surrounding Alumni Career Services in the 2007-2008 fiscal year. This means that UK grads who wanted to make employment changes sought out their alma mater as a viable resource to help them better their careers.

Through in-person appointments, e-mail consultations or telephone calls, 658 UK grads received career guidance. Alumni had 482 campus interviews with 74 employers, such as Humana, Ernst & Young, IBM, and Eli Lilly & Co.

### New Age Networking

Unquestionably, personal contacts are the most effective job search method, but Internet social networking sites have made the process much easier. Professional sites such as LinkedIn.com are quickly gaining popularity with features that not only allow you to multiply your contacts but also cross reference your e-mail contact list with those who may have links to your targeted employers. Recruiters also are increasing their usage of such sites to identify and prescreen candidates.

Another way to expand your network, increase your online visibility and build your professional presence is through blogging. This tool is quickly emerging as a way to identify industry experts. Consider adding this to your career management tool box.

### Challenging Interview Questions

I've recently spoken with several professional candidates who have been caught off guard by the basic interview request, "Tell me about yourself." This is typically brought up at the beginning of an interview and often appears to be more conversational in nature. As a word of caution, this is not the time or place to get personal, talking about the number of children you have, your family situation, or where you have lived. Seize the opportunity to immediately highlight your relevant education, skills, and experience (especially recent work experience), tailoring it to the position for which you are interviewing. Keep your response short, two to three minutes. To best prepare for an interview, use the Internet to research other common interview questions.

# Harold Tate

This series of articles has featured high-profile University of Kentucky alumni who left the Commonwealth to achieve early career successes and eventually returned to the Bluegrass Region to make a significant, positive impact, personally and professionally, on Central Kentucky and often beyond.

This article features Harold Tate, a UK College of Architecture grad who, after a very successful career within our Lexington City/Urban County government, also 'left.' However, Tate didn't leave Kentucky; instead, he retired - for a brief seven months - and then returned to embark on a second career in the public arena as President and Executive Director of the Lexington Downtown Development Authority.

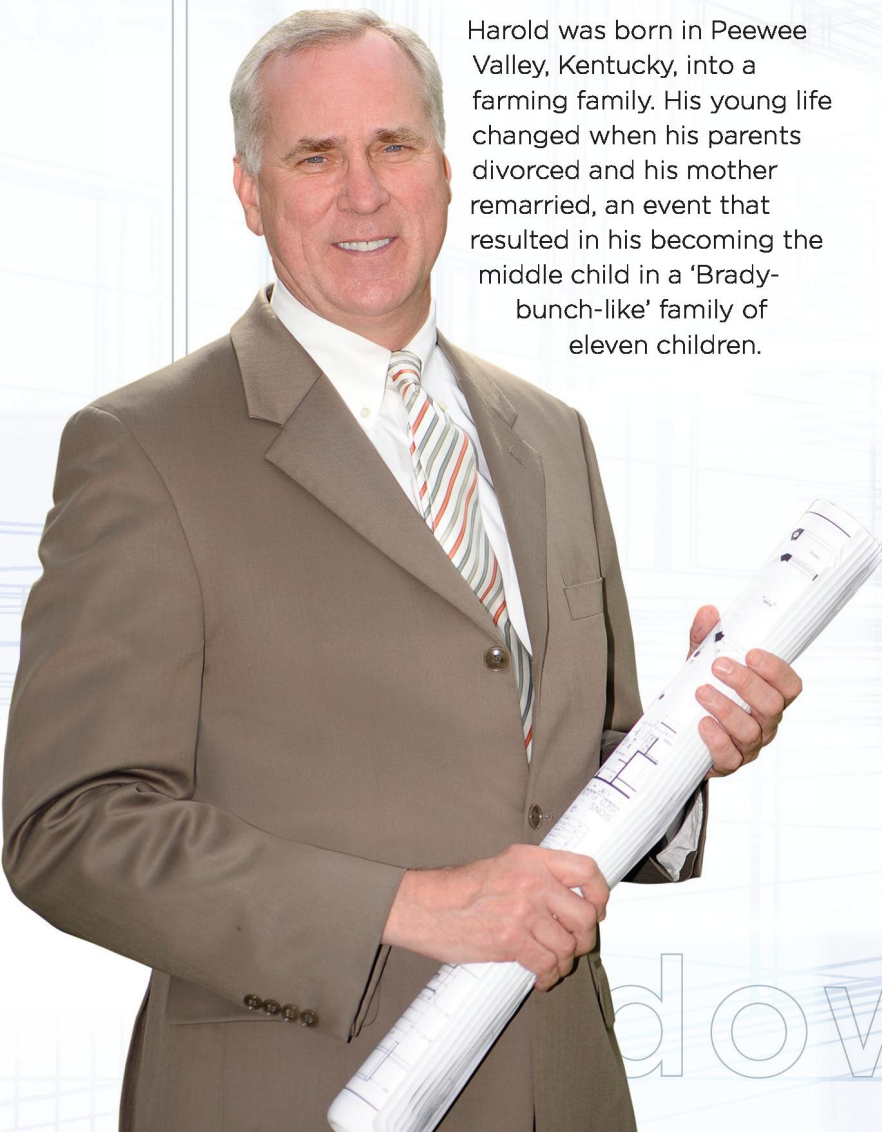
Harold was born in Peewee Valley, Kentucky, into a farming family. His young life changed when his parents divorced and his mother remarried, an event that resulted in his becoming the middle child in a 'Brady-bunch-like' family of eleven children.

In 1967, while he was still in high school, Harold 'escaped' to New York City to stay for an extended period of time with an older sister. While he was there he became totally fascinated with architecture - so much so that when he returned to Kentucky he enrolled at UK's School of Architecture, where his first work-study assignment was with the City's Parks and Recreation Department. Three years later his work-study challenge was actually to create architectural renderings of many of Lexington's historic buildings, e.g., Loudon House, Morton House, and Bell House. For his fifth and final year in Architecture school, his internship assignment was in Washington, D.C., again focusing on historic buildings and their preservation. After graduation, he returned to Lexington and began his remarkable career in public service, first with the City and shortly thereafter with the merged Lexington-Fayette Urban County Government.

"During the late 70s I wore many hats around here," Tate recalled. "In 1979 I worked with the local Community Development Block Grant Program, where I helped oversee the redevelopment of three downtown blocks, now Victorian Square, Triangle Center (then Festival Market), and the Lexington Dry Goods Building (now Portofino's and Thomas and King's corporate offices)."

Later, on behalf of the Urban County Government, he was significantly involved with the 24-month warp-speed design and construction of the new Fayette County jail as well as the new center-city twin courthouses. "After which," he smiled, "in 2001 I hung it up, slowed down, quit, retired, got out of the rat race." And how long did that last?

"Well, five months later [then] Mayor Pam Miller and [then] Dean of UK Architecture School David Mohney convinced me that I could help

build a stronger 'town and gown' relationship between the City and UK, so I agreed and accepted the challenge of heading up the newly created Lexington Downtown Development Authority." Tate immediately immersed himself in analyzing the innovative College Town study done by Ayers Saint Gross of Washington, D.C., and thereafter helped to plan the redevelopment of the Martin Luther King Boulevard corridor, which today connects the UK campus with downtown. He noted that highly desirable loft housing units were designed, built, and sold before construction was totally complete - setting the stage for a flurry of additional development that is part of the 'town and gown' area: Centre Court on South Upper, City Court, and the Kimball House Square redevelopment project.

Today Tate's brief retirement is ancient history. He often logs 14-16-hour days doing something for which he is uniquely qualified - 'selling' the City of Lexington, and in particular our downtown, to anyone and everyone he meets. One of his recent consensus-building projects was to work with Sylvia Lovely and the Kentucky League of Cities to secure funding from eight different Kentucky banks - capital that has been and can be used, at a much below-market interest rate - for 'seed money' for downtown projects.

## UK Grad Earns Two International Awards



**Kehai Li**, who earned a doctoral degree in electrical engineering from UK in 2007, received the distinguished Henry Granjon Award from the International Institute of Welding in July during its annual assembly in Graz, Austria. The Henry Granjon Award is a prestigious honor given after a competition among authors of papers involving research in welding technology. Every year, only one young welding researcher receives this award in each of four categories. Li's award was given in the category of joining and fabrication technology for a novel arc welding process, double-electrode gas metal arc welding, which uses a bypass torch to produce a higher wire melting rate with lower heat input to the base metal. That is, it adds an extra heat source to the traditional process to increase productivity, while avoiding the potential problems caused by overheating.

If that weren't enough good news, Li was contacted and told he also will receive the Sir William J. Larke Medal Award from The Welding Institute, United Kingdom. This award is bestowed biennially to honor the best contribution over the previous two years to advance the knowledge or practice of welding or joining. This honor is particularly rewarding because it is the result of a peer nomination process.

Li is a native of the Peoples Republic of China and today lives in Florence, S.C. He is employed by ESAB and his duties include researching and developing new welding and cutting equipment. He is a member of several professional organizations, including AWS, Sigma Xi, IEEE, ASME and SME.

The award is presented each year by the Department of Education and the Kentucky Council of Exceptional Children (KYCEC) to an outstanding special needs teacher and provides recognition of the work done to help students reach high levels of achievement.

She earned a bachelor's degree and Rank II in Moderate/Severe Disabilities from the University of Kentucky in 2001. She has been a teacher at Indian Trail Elementary for seven years and is a member of the Kentucky Council of Exceptional Children.

Meyer serves as a mentor teacher and a part-time instructor at the University of Louisville.

Meyer says, "Knowing that you have made a connection with a child whom others think is lost is an unbelievable, indescribable feeling ... once this connection is made, you are on your way to unlocking many, many other doors that will reveal the amazing people that our children are and their potential to become amazing adults."

School districts nominate individuals for the award. The Teacher of the Year receives a combination of rewards, which include a \$500 gift basket from the Department of Education, \$1,500 in cash from the KYCEC and Kentucky Colonel recognition. Meyer also is Kentucky's nominee for the National CEC Special Education Teacher of the Year award.

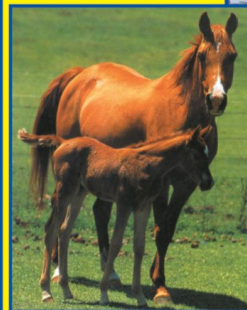

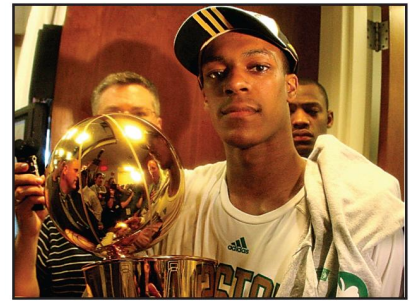

## Rondo Helps Lead Celtics To NBA Title

Former UK basketball player Rajon Rondo has ascended to the heights of the basketball universe, helping lead the Boston Celtics to their 17th title. Having one of the most well-rounded games in his young career, Rondo finished with 21 points, seven rebounds, eight assists, and six credited steals in leading the Celtics to a 131-92 win over the Los Angeles Lakers in Game 6 of the NBA Finals.

“He was the guy out there that made plays, got the steals, pushed their offense into high drive, and created havoc for us,” said Los Angeles Lakers coach Phil Jackson.

Rondo, who played at UK in the 2005 and 2006 seasons, helped lead the Wildcats to a 2005 NCAA Elite Eight finish, while setting the UK single season steal record with 87.

### Wildcats In The Olympics

The UK Track and Field squad sent the most Wildcats ever to the Olympics. A total of three current and former athletes and one coach headed to Beijing, China, for the 2008 Summer Olympic Games.

Sprinter Jose Acevedo, hurdler Mikel Thomas, former middle distance specialist David Freeman and assistant coach for sprints, hurdles and relays Erin Tucker made the trek to China.

The running crew joined two other UK athletes: current swimmer Elvis Burrows and former Wildcat basketball great Tayshaun Prince, who is now a member of the Detroit Pistons and helped lead the team to the 2004 NBA Championship.

The total of six Wildcat athletes matches the record total of the 1948 UK contingent when five men's basketball players and head coach Adolph Rupp made the trip to the summer games in London, England.

### Henderson Named Baseball Coach

Gary Henderson has been named the UK baseball coach, replaces John Cohen, who resigned to become the head baseball coach at Mississippi State. Henderson, UK's associate head coach and pitching coach for the past five years, becomes the 25th head coach in the 104-year history of Wildcat baseball.

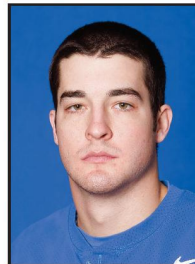
This is Henderson's second collegiate head coaching position. He was previously head coach at Chapman University where he helped transition the program to Division I, guiding the program to a national ranking in its first year. A former National Assistant Coach of the Year at Florida, Henderson has had assistant coaching stops at San Diego State, Fullerton State, Riverside CC, Pepperdine, Florida and Oregon State.

### Carroll, Cowgill Named First-Team All-America

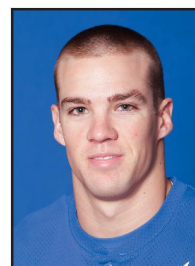
For the first time in the 104-year history of the Kentucky baseball program, two UK players — outfielders Sawyer Carroll and Collin Cowgill — have been named first-team All America as announced by the National Collegiate Baseball Writers Association.

Carroll has been a consensus first-team All-American, earning the distinction in all three All-America listings released in 2008: Louisville Slugger, Rivals.com and NCBWA. A first-time All-SEC selection, Carroll led the league with a .419 average and a school-record 83 record RBI. He set the UK career record for batting average (.386). Carroll was third-round draft pick by the San Diego Padres.

Cowgill set the school record for runs scored in a season (80). He hit .361 and had 60 RBI. Cowgill was a first-team All-SEC selection by coaches, as well as a second team All-American as selected by Louisville Slugger and Rivals.com. He was a fifth-round pick by the Arizona Diamondbacks.

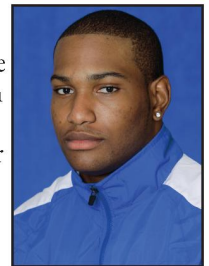

### Rashaud Scott Wins NCAA Discus Title

UK Track and field thrower Rashaud Scott won the men's discus national title with a throw of 199-8 at the NCAA Outdoor Championships. Scott is the first Wildcat to win a NCAA championship since former Olympian sprinter Tim Harden won the Indoor 55 meter dash for UK in 1996.

The UK men's 4x400 meter relay team broke the school varsity record by almost a second, finishing third with a time of 3:02.00. Senior Nathan Browning and Justin Harrison are joined on the relay team by junior Jose Acevedo and sophomore Kwasi Obeng.

UK secured its highest point total of 25 and best finish in the NCAA Outdoor Championship history by placing ninth in the country.

### UK Leads Nation In Attendance Again

UK led the nation in attendance in 2008-09 according to NCAA compiled attendance figures. UK's average crowd of 22,554 led all Division I men's basketball. It marks the 20th time in the 32-year history of Rupp Arena that Kentucky has had the top attendance figure. A total of 405,964 fans went through the turnstiles in downtown Lexington for 18 Wildcats games during the 2007-08 season.

The second meeting of the YWCA freshman group is held in Patterson Hall and Mrs. Frank McVey speaks on "The Development of a Charming Personality" . . . Maurice Chevalier stars in "The Way to Love" at the Kentucky Theatre . . . Thomas Hunt Morgan, UK Class of 1886, receives the 1932 Nobel Prize for Medicine . . . Harry Gamage, UK head football coach, resigns . . . Dr. J. Perrine of the American Telephone and Telegraph Company speaks at UK on "Television: Its Fundamental, Physical and Psychological Principles."

## 1958

UK installs its own Motion Picture Film Processing Center and becomes a part of a small percentage of colleges developing movies, with UK football games accounting for 3,200 feet of processing a week . . .
