The Faculty convened at 10 a.m., and first took action upon the death of Judge Kinkead. His connection with the College was feelingly set forth by President Patterson; after which Mr. White moved to appoint a committee of five to draft appropriate resolutions. Mr. Shackelford suggested that the President act as chairman of the committee. The committee, as appointed, consisted of Messrs. Neville, White, Shackelford, Laman, Nelson. It was resolved that the Faculty meet in a body at Dr. Pryor's office, and go to the church, and from there to the cemetery.

The chairman of the Committee on Determination of College Honors reported the action of that Committee, that Mr. Brand had been assigned first honors, and that no selection could be made between Messrs. Jones and Faig for second honors.

\* Mr. Kastle moved to give second honors to Mr. Faig, on the basis that general character should be taken into consideration, in such a matter, as well as the mathematical average of the grades.

\* After some discussion Mr. Nelson's substitute, to divide the second honors between Messrs. Faig and Jones, was carried. At the suggestion of Dr. Shackelford it was ordered that Mr. Jones give a salutatory in Latin, and Mr. Faig in English.
