The faculty met in regular session on Monday, December 11, 1916, Professor Miller presiding. Quorum present.

The secretary of the faculty read the minutes of the last metting which were adopted as read.

A petition was read from Owen Scott Lee requesting that his diploma be dated as of the class of 1915. On motion, it was voted to date Mr. Lee's diploma December 12, 1916, and it may be stated in the diploma that he graduated as of the class of 1916.

The secretary read a report from the Committee of Deans recommending that the Christmas holidays begin December 20th. instead of December 23rd. After a general discussion, the faculty authorized the holidays to begin Thursday morning, December 21st. and to end Tuesday night, January 2nd.

Professor Roberts read the following report from the Graduate School Committee:

1. That the names of those persons who were recommended and approved for honorary degrees at the Golden Jubilee, but were unable to be present, be held as egigible to receive the respective degrees at some proper future occasion when they may be able to be present.

2. The names of A. C. Gough, Pocatello, Idaho and A. R. Bennett of Eæst St. L Louis (1477-A Missouri Avenue) were presented by Dean Anderson and accepted by the Committee as condidates for the degrees of Electrical Engineer and Mechanical Engineer, respectively."

It was voted to defer action of this report until. the regular time for the report on candidates for higher degrees.

The following resolution from the Committee on Entertainments Non-Ath; etic was read and adopted:

1. All entertainments and social activities of every kind shall be held either on Friday or Saturday afternoons, or on the evening of the day before a legal holiday, and shall close at the hours hereinafter specified.

All such events shall be properly chaperoned, and not later than two weeks prior to the time of holding any one of same, the names of the chaperone for the occasion shall be given in writing to the Dean of Women of the above named Committee.

Besides selecting chaperones at least one member of the Committee or some one representing the Committee, designated by the Committee as its representative, shall attend the entertainments and remain until the close of same.

The name of the Committeeman or Committee representative shall be printed on the program as one of the chaperones.

2. It is desired and urged that all entertainments given by the student body shall be simple, free from ostentatious display and inexpensive, and as far as possible they shall be held in the Gymnasium or Armory.

The Junior Prom, Pan Hellenic, Tau Bata Pi and Alpha Zeta may hold of their dances at the Phoenix Hotel.

2. All dances shall be held on the campus with the exception with the of the above named.

All dances are under the supervision of the Committee and authorities of the University.

3. The Senior Dance and Junior Prom shall close not later than one o'clock. All other dances shall close at twelve o'clock.

Those organizations desire intermission for refreshments shall observe intermission from eleven to eleven-thirty.

4. Afternoon dances shall begin at three-thirty o'clock and close at five-thirty.

5. All clubs or organizations desiring to atrange for entertainment or amusement must apply

to the Committee for Privilege.

Unconventional dancing of any kind shall be prohibited. All persons and organizations violating, will be reported to the Discipline Committee.

## III

All organizations participating in musicals, receptions, dramatic plays, debates, oratorical and declamatory contests or any other entertainment or amustment shall be listed with the Committee on Entertainments.

## IV

A calendar showing time and place of all dances and entertainments shall be kept in the office of the Dean of Women, the calendar may be seen at any time by persons interested. This listing keeps dates from conflicting, and also insures the proper supervision of place and chaperones.

## V

- 1. All organizations giving an entertainment or dance shall sign a social form provided by the Committee, which provides for the naming of time and of place of entertainment, the list of chaperones who are responsible for the proper conduct of the entertainment or dance, and a list of the floor committee who shall see that proper order and sonditions are maintained.
- 2. All proposed itineraries of any organization such as Glee Clubs, etc., must be approved by the Committee.
- 3. The Committee Representative shall make a report in writing of the conduct of the dance.

## HOUSE DANCES.

- 1. Fraternity House Dances may be held at their respective houses, but no one fraternity shall hold more than two such dances during the year. They shall be chaperoned as all other dances, and be listed on the Social Form provided for entertainments and dances. They must be scheduled as all other dances. Light refreshments may be served. The House Dance must close at eleven o'clock.
- 2. A representative from the Committee or from the Faculty shall be present at every House Dance, and a report of the dance shall be made to the Dean of Women for filing.
- 3. When a Fraternity House has no room for a dance it shall be given on the campus."

The faculty adjourned to meet Friday, December 15th. to consider a petition from the battalion in regard to compulsory chapel.
