A. M. College, December 22nd 86
Faculty met at 12 M. in called meeting in the President's room. All present except Pres. Patterson. Prof. Shapleford is called to the chair. There came before the Faculty a Committee of the Students of this College, asking permission to establish a second Literary Society, to be called "The Patterson Literary Society". Constitution and Rules of the new society are laid before the Faculty. On motion it was resolved to grant the petition and to sanction the Constitution and Rules.

Col Phelps of the Board of Discipline reports Cadets Pope and that Cadets J. W. Pope, J. R. Buckman and Worth Buckman had left College without leave and against express orders. Moved and seconded that Pope and Buckman be dismissed College. Carried. The case of Worth is laid over for further consideration.
