REVISED RULES OF THE COMMITTEE ON ENTERTAINMENTS NON-ATHLETIC, SUBMITTED TO THE FACULTY AND ADOPTED JUNE 3, 1913.

All entertainment and social activities of every kind shall be held either on Friday or Saturday afternoons, or on the evenings of Friday or Saturday, or on the evenings of the day before a legal holiday, and shall close on the hours hereinafter specified. All such events shall be properly chaperoned, and not later than two weeks prior to the time of holding any one of same, the names of the chaperones for the occasion shall be given in writing to the Dean of Women of the above named committee. Besides selected chaperones, at least one member of the Committee or some one representing the Committee, designated by the Committee as its representative, will attend the event and remain until the close of same. The name of the Committee-man or Committee representative shall be printed on the program as one of the chaperons. It is desired and urged, that all such events given by the student body shall be simple, free from ostentatious display and inexpensive, and as far as possible they shall be held in the gymnasium, Armory or Patterson Hall.

Dances shall not be held during the year in any greater number than herein set out as follows:-

Senior Dance, Junior Prom, Pan-Hellenic, Sophomore Dance, Lamp and Cross, Three Greek Letter Fraternity Dances and the two Honorary Associations, Tau Beta Pi, Alpha Zeta.

The Senior Dance must close not later than 2 o'clock. All other dances here named held on the University campus shall close at 12 o'clock, those held at the Phoenix shall close not later than one o'clock with an intermission of 30 minutes, from 11 to 11:30.

There may be one night military ball, which shall close not later than 12 o'clock and the following afternoon dances: One Freshman, Four Cadet Hops and six other dances which will be distributed by the Committee among other societies and organizations of the University, not above provided for, which shall close not later than 5:30.

Private Fraternity dances may be held at their respective houses, but no one fraternity shall hold more than two such dances any one year, and they shall be chaperoned as above stated and close at 12 o'clock. These dances must be scheduled by the Committee like all other dances.

There shall not be during any one week, more than one dance permitted, exclusive of the Fraternity house dance.

Unconventional dancing of every kind is strictly prohibited in all dances given by the students of the University. Any student violating this provision will be disciplined by the proper authorities. Any organization not complying with the rules herein shall forfit its dancing privilege.

The names of parties participating in musicals, receptions, dramatic plays, debates, oratorical and declamatory contests, or any forms of amusements, must be submitted to this committee not later than two weeks preceding each contemplated performance, and the time for holding same shall be fixed by the committee. All proposed itineraries by any such organization must also be approved by the Committee.

A calendar showing time and place of all events of any kind as stated above, will be kept in the office of the Registrar, and also a copy kept in the office of the Dean of Women. The calendar may at any time be seen by persons interested.

Judge Lafferty presented a second resolution upon the subject of the University dances, as follows, and moved its adoption:

"Resolved: That hereafter in all dances given under the auspices of the University or any student organization, whether upon the campus or elsewhere, no such dance known as the "Turkey Trot", "Drag", or any other unconventional dance shall be allowed. The University Committee having in charge such entertainments shall see that this resolution is made known to all organizations affected by it, and report all violations."

The resolution was seconded by Dr. Pryor and after brief comments by Dean Hamilton, Prof. Zembrod and others, was adopted.

Prof. Gillis reported to the faculty, a recent action of the students relative to the honor system, as follows, and moved its ratification: Resolved: That Article V., Section 7 of the present constitution be amended to read as follows: In all cases of cheating on tests or examinations, the Committee shall, when the accused is found guilty, suspend him from the University for a period of one month; for the second offense the student shall be expelled from the University.

The above resolution was adopted by the student body.

The motion was duly seconded and was discussed by Prof. Miller, White, Davis and Gillis, the opinion being quite generally expressed that the action, as taken by the student body, would better undergo some modification, but upon the suggestion of Prof. Gillis that the action would in any case probably be amended soon by the student body, its ratification was approved upon an aye and no vote of fourteen ayes and thirteen noes.

On motion, the faculty adjourned.
