PREFACE

The publication herewith presented, an index to the probate cases filed in Liberty County, Texas, is No. 146 of the Texas series of counties. The publication is intended to meet the requirements of day-to-day usage by the officials of the county, attorneys, businessmen, and other citizens who have occasion to consult probate case records for the proper conduct of their affairs. The publication may be used by historians and genealogists to obtain references to unpublished source material.

The names of the deceased persons, minors, and other principals are arranged alphabetically, with reference to the filing date of the case and the case number. The notation "no papers" following the name of the principal indicates that no case papers were located during the inventory. Differentiation between probate cases assigned duplicate numbers is accomplished by the addition of a letter following the case number. The prefixes "T", "J", "L", "E", and "I" are used to denote tuberculosis, juvenile, lunacy, epilepsy, and infirmity cases. Case numbers preceded by "O" were assigned to previously unnumbered cases. The following numbers in the series 1-3145 were not used as case numbers: 104, 375, 397, 619, 621, 742, 965, 979, 993, 1034, 1110, 1291, 1379-2999.

In Liberty County the probate case papers are filed in the county clerk's vault on the first floor of the courthouse. The papers, filed in separate jackets, are arranged chronologically according to filing date under alphabetical subdivisions corresponding to the first letter of surname of the principals in plainly marked steel file drawers.

Since the transfer of territory from one county to another has affected probate jurisdiction and has determined the county in which the probate cases should be filed, a map and table of territorial changes are included herein. Notations concerning present location and availability of records pertinent to Liberty County follow:

Harris County, Houston, records extant.

Montgomery County, Conroe, records extant.

Washington County, Brenham, records extant.

EXPLANATION OF THE MAP AREAS AND THEIR DERIVATIONS

By a decree of Jan. 31, 1831, dividing Texas into two departments (H. P. N. Gammel, Laws of Texas, I, 281), territory of the map areas A-G, L-O, and AA fell within the Department of Bexar; map areas H-K, P-Z, BB-EE, and the area of Liberty not cross-hatched in the Department of Nacogdoches.

Neither the date of establishment nor legal definition of the boundaries of the municipality of Liberty is available. 1831 is here given as a starting date for the municipality because it is believed that in February of that year Francisco Madero established an ayuntamiento at the town of Liberty (see H. H. Bancroft, The History of Texas and the North Mexican States, II, 116; Eugene C. Barker, Mexico and Texas, p. 105; see also Arlene Pickett, Historic Liberty County, p. 13, for statement that Hugh B. Johnston was appointed the first alcalde of Liberty in February 1831). Roughly, the original territorial jurisdiction of the municipality of Liberty extended from the San Jacinto River to the Sabine, and from the southern line of the municipality of Nacogdoches to the Gulf (George W. Paschal, A Digest of the Laws of Texas, I, 178, note 314; John and Henry Sayles, Early Laws of Texas, I, art. 1555; and see also "Descriptions of Texas by Stephen F. Austin, 1833," Southwestern Historical Quarterly, XXVIII (1924-25), 118). For the western boundary line of the municipality of Liberty on the accompanying map, the legal definition of the eastern line of Austin's Colony was used (see Gammel, I, 50). The line shown as the northern line is what is assumed to have been the southern line of the municipality of Nacogdoches. This line was apparently never defined. It was platted from careful study of legal boundary definitions of numerous municipalities and counties subsequently created from territory of Liberty and of Nacogdoches (Houston, see Gammel, I, 1330; Robertson, ibid., I, 1398; Angelina, ibid., II, 1426; San Augustine, ibid., I, 352).

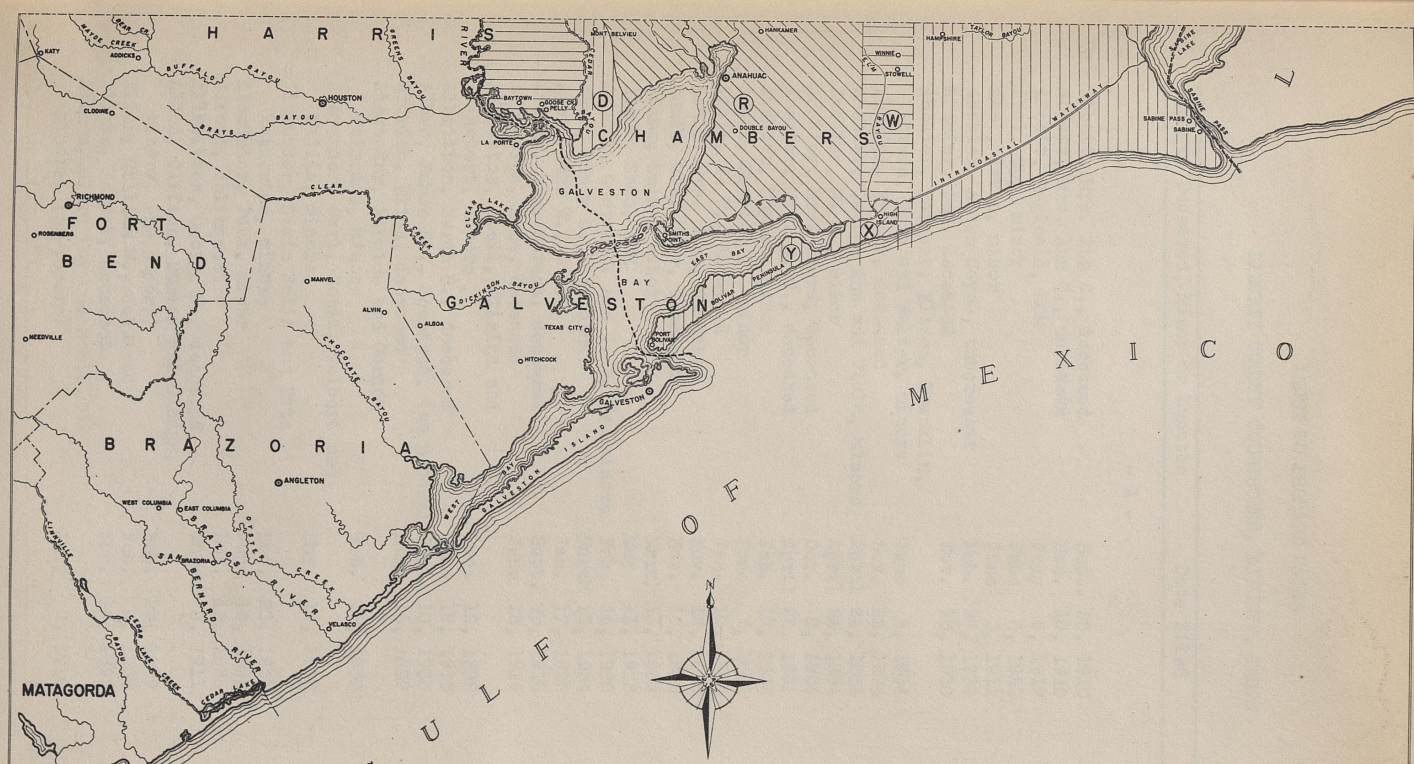
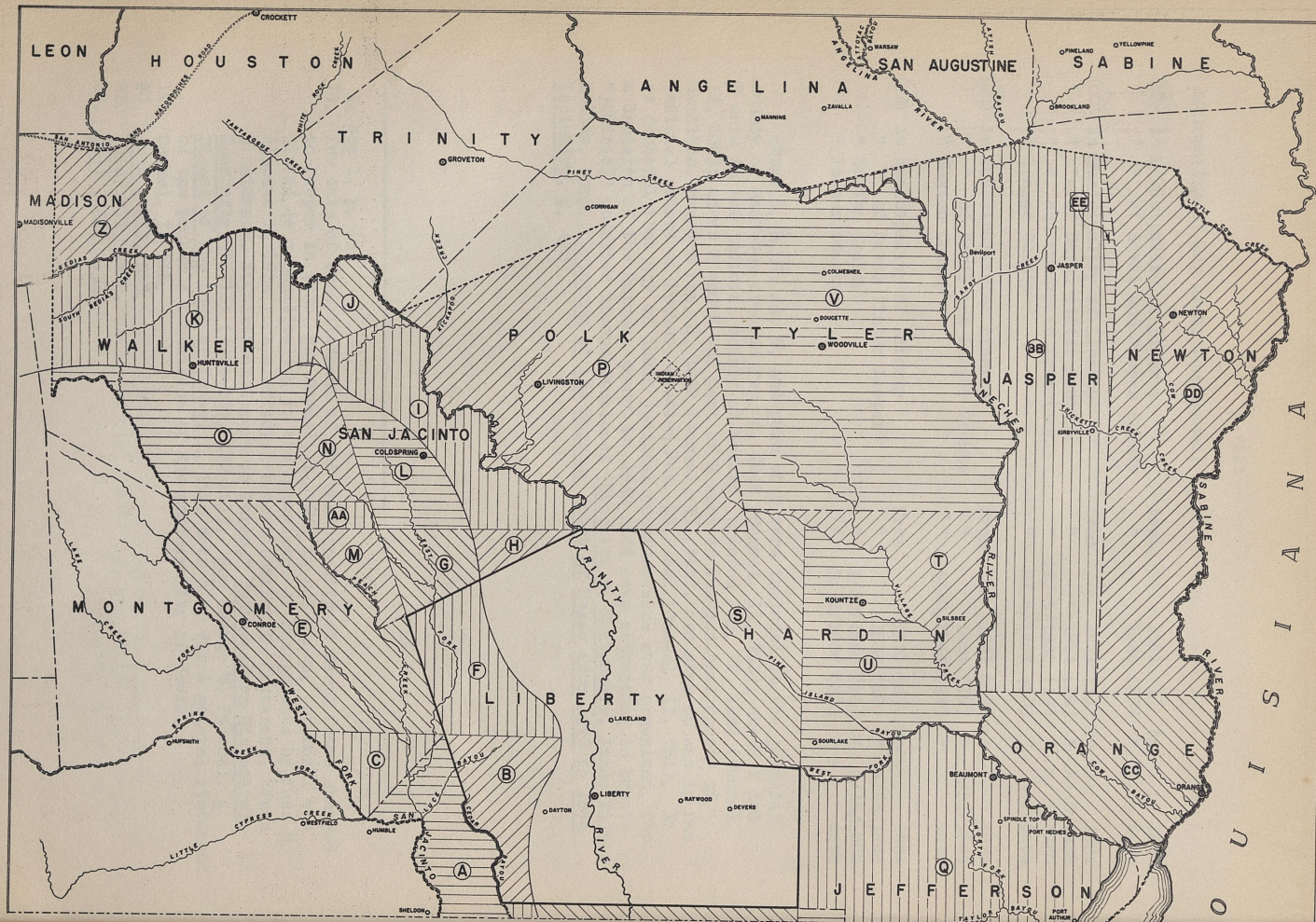

Areas C, E, M, AA, N, and part of O were included in the judicial county of Madison, created Feb. 2, 1842 (Gammel, II, 763); areas V and T were in the judicial county of Menard, created Jan. 22, 1841 (Gammel, II, 538); areas J and K and part of Z were in the judicial county of Hamilton, created Feb. 2, 1842 (Gammel, II, 763); and area CC was in the judicial county of Neches, created Jan. 29, 1842 (Gammel, II, 754). It is doubtful that any of these judicial counties were ever organized, for a decision of the Supreme Court in 1842 held acts attempting to create "judicial" counties unconstitutional (Stockton v. Montgomery, James Wilmer Dallam, comp., Opinions of the Supreme Court of Texas from 1840 to 1844 Inclusive, p. 473).
