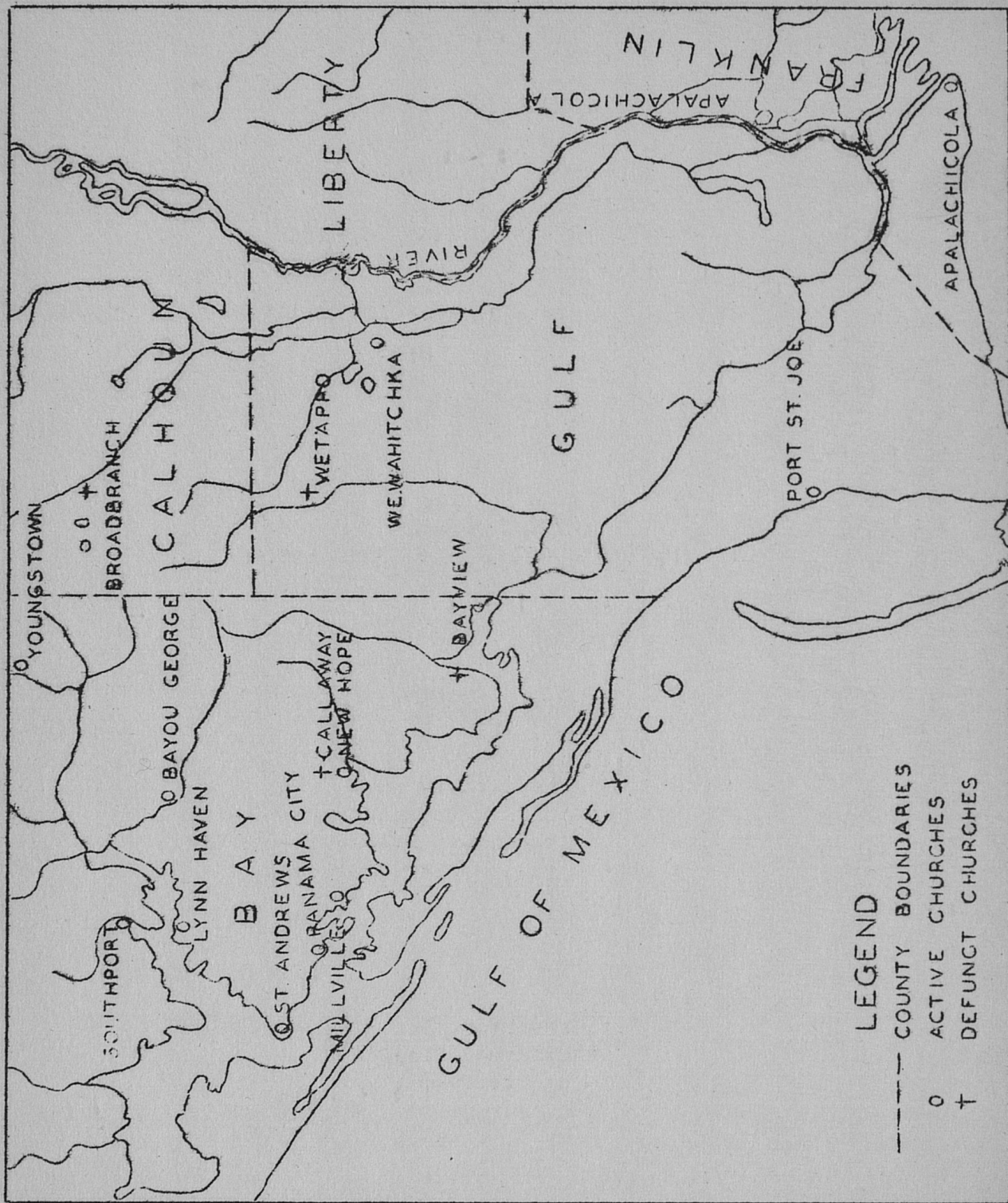

PREFACE

The Historical Records Survey program operates as a series of state-wide projects in the several states under the Research and Records Section, Division of Professional and Service Projects, Work Projects Administration. The program was organized in Florida in 1936 under the national direction of Dr. Luther H. Evans. On March 1, 1940, Dr. Evans left to become Director of the Legislative Reference Service of the Library of Congress, and was succeeded by Sargent B. Child.

The Survey is engaged in the preparation of inventories of, and bibliographical guides to, source material hitherto inaccessible to research workers. The Survey program in Florida, as throughout the nation, includes an inventory of state, county, municipal, and church archives, of American imprints, and of manuscript depositories and collections.

The Church Archives Inventory represents an important phase of the Survey for it is through this inventory that many unknown and unusual religious records of interest to historians and genealogists will be located. The records of individual churches are being inventoried and these inventories will be grouped and published by denominations.

This volume is the tenth of a series of inventories to be published in local and district groups within denominational bodies in Florida. Later these district surveys may be combined into volumes by denominations and published for the whole state. The inventory of each district group includes an entry on the district organization, on each active church and mission connected therewith, and on churches that became defunct while associated with the group.

The Northwest Coast Baptist Association is one of thirty-six district associations holding membership in the Florida Baptist State Convention, an affiliate of the Southern Baptist Convention.

Churches listed have weekly services unless otherwise

stated in the entry. The educational background of the pastor is unknown if not given. The actual titles of records are written in full capitals, assigned titles of records are written in full capitals and are enclosed in parentheses, explanatory titles are written with initial capitals and are enclosed in parentheses. All records are located in the church building unless the names and addresses of the official custodians are given. Records not reported are either missing or destroyed.

This volume was compiled and edited under the direction of Gordon C. Reeves, Church Editor, in accordance with technical instructions from the Washington Office of Historical Records Survey Projects. It was reviewed by Donald A. Thompson, Assistant Archivist in charge of Church Archives Inventories. The field inventory for this volume was made by Mrs. Frances Sanders.

The publications of the Historical Records Survey are issued for free distribution to public and institutional libraries. 1. NORTHWEST COAST BAPTIST ASSOCIATION, 1934-- (Also known as North West Coast Baptist Association).

The Northwest Coast Baptist Association was organized in 1934 by churches situated in Bay, Gulf and that portion of Calhoun County lying south of Blountstown.(1) All of the churches which united in forming the new association withdrew from the West Florida Baptist Association in 1934 in order to form an association which would be geographically more compact

The organization session was held on Oct. 18, 1934, in the First Baptist Church, Wewahitchka, with the following churches represented: Broad Branch, Lynn Haven, Millville, Panama City, Youngstown, Port St. Joe, Southport, Wewahitchka, St. Andrews and Wetappo.(2) Rev. E.D.McDaniel of Panama City was elected moderator; Rev. G.C.Rish of Wewahitchka as vice-moderator; C.G.Costin of Port St. Joe as clerk, and W.L. Brock of Youngstown as treasurer.(3) Committees appointed for the purpose of formulating a Constitution and By-laws for the association, reported during the afternoon and the Constitution was adopted.(4)

The first annual session was held at Wewahitchka church Nov. 19-20, 1935, with Rev. E.D.McDaniel, moderator; Rev. E.H.Garrott, vice-moderator; C.G.Costin, clerk; and T.D.Levins, treasurer.(5)

The Apalachicola, Callaway and Bayview churches were accepted into membership at this meeting.(6) The former church came from the Florida Baptist Association and the two

latter churches from the West Florida Association; New Hope was added at the 1937 meeting.(7) The Bayou George church organized in 1939, joined the association in the same year.

(8) The losses to the association have been: Wetappo, which became defunct prior to the first annual session 1935, (9) and Callaway which became defunct in 1936.(10)

The general object of the association is to aid the Florida Baptist State Convention "in the propagation of the gospel at home and abroad, and to deepen the spiritual life, increase fellowship, and promote cooperation among the churches".(11)

The constitution as originally adopted, designates that the association be composed of messengers from member churches. There is no stipulation limiting the number of messengers. When an elected messenger is unable to attend, any member of that church in good standing may be enrolled and recognized. (12) The churches sending messengers must provide the messengers with a letter giving the statistics of the church, work accomplished, money for missions, and printing of the minutes and a list of church officers.(13)

Churches desiring to join the association submit a letter of application or petition and if these documents are found orderly according to the Baptist faith, the moderator extends the right hand of fellowship to the church.(14)

The constitution provides for a moderator, a vice-moderator, a clerk, and a treasurer, each to be elected annually. by the messengers to the association.(15) No remuneration

was provided for any officer, but the treasurer's report for 1935 mentions a sum of \$10.00 which was to be paid to the clerk or any one whom he might designate to prepare the minutes for publication.(16) In 1936 this was raised to \$45.00, (17) in 1937 to \$20.00,(18) and in 1939 to \$30.00.(19)

The duties of the moderator, assisted by the vice-moderator, are to preside over the body, keep order, take the vote on all questions and to perform all duties necessary to the office.(20) Those who have served in these capacities have been: moderator, Rev. E.D.McDaniel, 1934--; vice-moderators: Rev. G.C.Rish, 1934; Rev. E.H.Garrott, 1935-37; Rev. J.W.Sisemore, 1938--.(21)

The clerk is responsible for all papers and documents committed to his care, keeping correct minutes of the proceedings of the association and preparing these for publication.(22) Clerks who have served the association have been: C.G.Costin, 1934-36; Miss Estelle Hall, 1936; Mrs. J.J.Roache, 1937--.(23)

The treasurer receives all funds for the association and disburses them on orders from the association finance committee. He prepares an annual statement of finances for publication in the minutes, showing all receipts and disbursements. (24) Treasurers who have served since the organization have been: W.L.Brock, 1934; T.D.Levens, 1935-37; J.C.Alexander

1937; W.R.Nichols, 1938--.(25)

An Executive committee, consisting of one member from each church holding membership in the association, constitutes the association *ad interim* and conducts the business of the association between annual meetings.(26) Since 1937 the chairman is proposed by the nominating committee and elected at each annual session. He is empowered to call meetings, and furnish an order of business for the annual session.(27) The moderator is to furnish the order of business for the annual session when the chairman of the executive committee is unable to do so. The moderator, Rev. E.D.McDaniel has served as the chairman of the Executive Committee since its inception.

A constitutional amendment adopted in 1937 provides for a nominating committee consisting of three members, appointed annually by the moderator. This committee nominates a member of the State Board of Missions, a delegate to the Florida Baptist State Convention, a delegate to the Southern Baptist Convention and the chairman of the executive committee.(28)

Another amendment adopted in 1937 provides for a finance committee for the purpose of collecting monies to be paid to the treasurer. It is composed of the clerk, treasurer and one other member elected by the association.(29)

Although the constitution does not mention associational auxiliaries, two active auxiliaries function in the association, the Associational Woman's Missionary Union and the Associational Baptist Training Union. The former was organized the same year as the association,(30) while the latter was organized in 1936. Both auxiliaries hold their annual meetings at a different time than the association, but both make reports to the

association at its annual meeting.(31)

The duties of other committees are not given in the constitution. There follows a list of committees which have reported to the body; the chairman of each committee and the year reports were made.(32)

The closing article of the Constitution provides that it may be altered or amended by a majority vote at any annual session. (34)

Rev. O.T.Moncrief served as associational missionary, supported jointly by the association and the State Mission Board of the Florida Baptist Convention from 1937 to July, 1939. The association has sponsored preaching stations at various times at Wetappo since that church became defunct, and at Highland City. This work, however, has never been on a permanent basis.

2. FIRST BAPTIST CHURCH OF APALACHICOLA, 1848-c1880, 1885--. (Calvary Baptist Church, 1901-36). 46 Ninth Street, Apalachicola, Franklin County.

Constituted 1848, incorporated Apr. 7, 1936. About 1850 a frame building was erected on the corner of Ave. G and 6th St. During the Civil War, services were discontinued account of occupation of the city by Federal troops, causing most of the population to flee. After the war, the building in bad condition was rebuilt and used until the church again lapsed in the early eighties. The church was reorganized in 1885 and services were held in the Florida House Hotel and the Methodist church until 1886 when the church was again rebuilt; later further improved and is now used as a dwelling. Present white, T shape, frame building, with steeple and bell, and 3 stained glass windows, erected 1902-04, dedicated 1910; remodelled 1910, 1921, 1935. Seven Sunday School rooms were added in 1925. Present membership, 211. Active organizations, Sunday School, Baptist Training Union, and Woman's Missionary Union with 5 auxiliaries. Earliest known pastor, Rev. E.H. Warren, 1856. present pastor, Rev. Paul McCullers, 1940--, 44 9th St., Apalachicola; Southwestern Theological Seminary, Ft. Worth, Tex.

3. SOUTHPORT BAPTIST CHURCH, 1876--, (Grassy Point Baptist Church, 1876-1913). 1/8 mile west of State Highway 52, Southport, Bay County.

Constituted 1876. First services in log building at Grassy Point. Prior to 1888 a two-story frame building erected near first building; lower floor was used for church and school, upper floor known as Alliance Hall. This building was partially destroyed by hurricane in 1894 and never used again. Location of services 1894-99 unknown. The next building was erected 1899 at Bradley Point, North Bay, and used until 1907. Services from 1907 to 1913 were held in second floor of Sale-Davis Company Store building, Southport School building and Methodist Church. Reorganized in 1913, and present unpainted, rectangular, frame building erected and dedicated May 1913 and name changed to Southport Baptist Church. A quarter-time church, meeting 1st Sunday. Present membership, 18. First settled pastor, Rev. E.D. Nelson, 1876-80. Present pastor, Rev. Grover Claud Rish, 1940--, Wewahitchka; Thomas Industrial Institute, De Funiak Springs, Fla.

4. FIRST BAPTIST CHURCH OF WEWAHITCHKA, 1879--.
(Chipola Lake Baptist Church, 1879-94). We-
wahitchka, Gulf County.

Constituted June 26, 1879. Services in log community building near present intersection of Highways 6 and 52, near Lake Alice and in the Methodist church, which the Baptists helped to build, from c1884-c1892. Present white, rectangular, frame building, with steeple and bell, was erected 1892-94. Present name adopted May 19, 1894. This church absorbed the Bellview Baptist Church, Wewahitchka, Sept. 17, 1899 and moved to present site. Building remodelled 1899- 1901. Present membership, 150. Active organizations, Sunday School, Baptist Training Union, Woman's Missionary Union with 2 auxiliaries. First settled pastor, Rev. T.E.Langley, June 26, 1879-Oct. 23, 1880. Present pastor, Rev. Edmund Hails Garrott, 1940--, Wewahitchka; Bethel College, Russellville, Ky.

5. YOUNGSTOWN BAPTIST CHURCH, 1886-- . (Pleasant Hill Baptist Church, 1886-1913). $\frac{1}{4}$ mile east of Atlanta and St. Andrews Bay Railroad depot, U.S.Highway 231, Youngstown, Bay County.

Constituted Aug. 15, 1886, at Nixon, 2 miles south of Youngstown. The first building of logs was also used as a school. In 1905-06, a rough, unpainted, frame building was erected. Services began being held also in school building in new settlement, then at Youngstown. For a time services held in both places under Pleasant Hill auspices. Present rectangular, white, frame building, with steeple and bell, occupied Oct. 12, 1913, and name of church changed to Youngstown Baptist Church. A quarter-time church, meeting on 2nd Sunday. Present membership, 78. Active organization, Sunday School. First settled pastor, Rev. John Stuart, 1886-88. Present pastor, Rev. Andrew Lowery, 1940-- , Kinard. See Historical Sketch written January 1889 in CHURCH RECORD, vol. 1. See *infra*.

6. ST. ANDREWS BAPTIST CHURCH, 1894-- . 3204 Wyoming Avenue, Panama City, Bay County.

Constituted Apr. 29, 1894 in St. Andrews School building which was used for services until a storehouse on Wyoming Ave., purchased and converted into a chapel, 1895; January to June 1902, services were held in St. Andrew's Presbyterian Church. Present

white, rectangular, frame building, with steeple, bell, and 2 art glass windows was occupied June 13, 1902, dedicated June 22, 1902. Sunday School rooms were added in 1898-99, 1936-37. Present membership, 233. Active organizations, Sunday School, Baptist Training Union and Woman's Missionary Union with 3 auxiliaries. First settled pastor, Rev. M.J. Webb, 1894-96 and 1898-99; Southern Baptist Theological Seminary, Louisville, Ky. Present pastor, Rev. O.T. Moncrief, 1939-- , St. Andrews; Mercer University, Macon, Ga.; Southern Baptist Theological Seminary, Louisville, Ky. See Historical Sketches, "Organization to March 28, 1905" and "Organization to February 1929", the latter by Dr. Wilson A.
